Beginning at a point, said point being 29.99 feet left of station 20+45.00, said point being the point of beginning;

Thence S 13°43'47" W a distance of 12.00 feet to a point, said point being 41.99 feet left of station 20+45.00;

Thence in a westerly direction with a curve to the left with a radius of 307.99 feet, having a chord bearing of N 81°10'51" W and a chord distance of 52.74 feet, having a central angle of 09°49'22" and an arc length of 52.80 feet to a point, said point being 41.99 feet left of station 21+05.00:

Thence N 03°54'27" E a distance of 12.00 feet to a point, said point being 29.99 feet left of station 21+05.00;

Thence in a easterly direction with a curve to the right with a radius of 319.99 feet, having a chord bearing of S 81°10'51" E and a chord distance of 54.79 feet, having a central angle of 09°49'22" and an arc length of 54.86 feet to the point of beginning.

The centerline described in this document refers to the centerline of construction as shown on the City of Columbus roadway plan "Campus View Boulevard Sidewalk Improvements (3114 Dr. E)".

The basis of bearings in this description area based on the State Plane Coordinate System, Ohio South Zone, NAD83 (NSRS 2011), which were determined by GPS observations conducted by the Patrick Engineering survey staff. The Columbus, Mount Vernon and McConnelsville CORS stations were used, which establishes a bearing along the centerline of Campus View Boulevard to be S 86°49'53" E between High Street and Vantage Drive.
