This memorandum is a recommendation for construction contractor selection and processing the construction legislation for the UIRF – North High Sidewalk at Overbrook project.

Project Scope: This project will replace approximately 382 linear feet of existing concrete curb, sidewalk and fence along with adding a retaining wall on the east side of High Street between Croswell Road and Overbrook Drive. ADA compliant curb ramps to cross High Street and Overbrook Drive are also included.

Fiscal Impact: Source of funds are DOD SIT Cert.

Schedule: Bids were opened June 24, 2010; estimated Council date is July 21, 2010; estimated NTP date is August 16, 2010. The contract length is 75 days from the date of the Notice to Proceed.

Engineer's Estimate: \$173,887.70
