[Surveyor's description of the premises follows]

Situate in the State of Ohio, County of Franklin, City of Columbus, being located in Half Section 52 in original Truro Township, Township 12, Range 21 of the Refugee Lands. The herein described parcel lies on the left side of the existing centerline of Right-of-way of Refugee Road. All bearings and distances, stations and offsets are based on the Right-of-Way plans prepared by Burgess & Niple for the City of Columbus as shown on the centerline plat for Refugee Road as recorded in Plat Book 125, pages 58 – 61 of the Franklin County Recorder's Office and as on file with the City of Columbus in plan 3419-E. Being part of lands conveyed to the "THOMAS A. MCDOWELL AND ALLEN E. MCDOWELL, DIANE A. MCDOWELL UNDER AGREEMENT FBO DIANE A. MCDOWELL DATED 1-2-1966, EQUALLY" (hereafter referred to as Grantor) as described in Deed Book 3559, page 28 of the Franklin County Recorder's Office and being more particularly described as follows:

COMMENCING at 62.04 feet left of the existing centerline of right-of-way of Refugee Road at station 45+86.78 and the **TRUE POINT OF BEGINNING** of the herein described parcel;

THENCE North 04 deg. 05 min. 57 sec. East for a distance of **1.77 feet** to 63.81 feet left of the existing centerline of right-of-way of Refugee Road at station 45+86.78;

THENCE South 89 deg. 42 min. 06 sec. East for a distance of **63.39 feet** to 68.34 feet left of the existing centerline of right-of-way of Refugee Road at station 46+50.00;

THENCE South 86 deg. 46 min. 57 sec. East for a distance of **200.10 feet** to 72.47 feet left of the existing centerline of right-of-way of Refugee Road at station 48+50.05;

THENCE South 84 deg. 02 min. 52 sec. East for a distance of **275.35 feet** to 65.00 feet left of the existing centerline of right-of-way of Refugee Road at station 51+25.30;

THENCE South 85 deg. 36 min. 08 sec. East for a distance of **311.45 feet** to 65.00 feet left of the existing centerline of right-of-way of Refugee Road at station 54+36.75;

THENCE South 85 deg. 41 min. 08 sec. East for a distance of **49.04 feet** to 65.00 feet left of the existing centerline of right-of-way of Refugee Road at station 54+85.88;

THENCE South 84 deg. 32 min. 12 sec. East for a distance of **51.14 feet** to 63.97 feet left of the existing centerline of right-of-way of Refugee Road at station 55+37.01;

THENCE South 87 deg. 30 min. 57 sec. East for a distance of **112.69 feet** to 67.57 feet left of the existing centerline of right-of-way of Refugee Road at station 56+49.64;

THENCE South 78 deg. 12 min. 13 sec. East for a distance of **47.77 feet** to 61.35 feet left of the existing centerline of right-of-way of Refugee Road at station 56+97.00;

THENCE South 87 deg. 22 min. 22 sec. East for a distance of **36.62 feet** to 67.62 feet left of the existing centerline of right-of-way of Refugee Road at station 58+86.29;

THENCE South 04 deg. 03 min. 08 sec. West for a distance of **7.62 feet** to 60.00 feet left of the existing centerline of right-of-way of Refugee Road at station 58+86.33;

THENCE North 85 deg. 39 min. 05 sec. West for a distance of **761.01 feet** to 60.00 feet left of the existing centerline of right-of-way of Refugee Road at station 51+25.23;

THENCE North 84 deg. 02 min. 52 sec. West for a distance of **275.29 feet** to 67.47 feet left of the existing centerline of right-of-way of Refugee Road at station 48+50.04;

THENCE North 86 deg. 46 min. 57 sec. West for a distance of **263.31 feet BACK TO THE TRUE POINT OF BEGINNING.**

The above-described parcel contains 0.140 acres total, including acres in the present road occupied (PRO), lying in Franklin County Auditors parcel number 010-016465.

The basis of bearings for the above-described parcel are based on the Grid North and the Ohio State Plane Coordinate System, South Zone, NAD83(2011), as established from a GPS survey utilizing the Ohio Department of Transportation's Virtual Reference System (VRS), performed by OHM-Advisors in November, 2015 and as expressed on said Right-of-Way plans and Centerline Plat prepared by Burgess & Niple for the City of Columbus on the existing centerline of Refugee Road by a monument box, located at the center of the box lid, at station 10+00.00 and a 1" rebar set in pavement at the centerline intersections of Refugee Road and Schwartz Road at station 28+89.33 with a bearing of South 85 deg. 43 min. 08 sec. East.

This description was prepared by Burgess & Niple, under the direct supervision of Michael D. Jones, P.S., Ohio License No. 8459 and is based on a recent survey of the existing boundary monument locations performed by OHM Advisors, under the direction of John Raab, Professional Surveyor, Ohio License Number 7863, under a sub-consultant agreement between Burgess & Niple and OHM Advisors, for said services.
