Situated in the State of Ohio, City of Columbus, Franklin County, Half Section 27, Township 5, Range 22, and part of a 3.926 acre tract conveyed to Grange Mutual Casualty Company, an Ohio Mutual Insurance Company, in Instrument Number 200705150084916, as recorded in the Franklin County Recorder's Office. The below described parcel laying on the left side of the proposed centerline of right of way for Short Street in project SHORT STREET as platted by 2LMN, Inc. as recorded in Plat Book 127, Page 84-85, and being more particularly described as follows:

COMMENCING at the iron pin set at the grantor's northwest corner, on the east line of a 44.960 acre tract conveyed to the State of Ohio, as conveyed in the Canal Lands Act of 1825, and leased to Columbus and Southern Ohio Electric Company, in Lease Record 83, Page 346, and the south existing right of way for Sycamore Street, dedicated to the City of Columbus in Instrument 200410220245227, said pin being 25.11 feet left of centerline of Short Street at station 10+05.18 and being the **TRUE POINT OF BEGINNING** for the parcel herein described:

- 1) **Thence**, along the grantor's north line and the south right of way line for Sycamore Street, **North 81 degrees 49 minutes 19 seconds East, 86.18 feet** to a point, said point being 25.00 feet left of the centerline of Short Street at station 9+20.00;
- 2) **Thence**, across the grantor's tract, **South 10 degrees 15 minutes 10 seconds West, 15.81 feet** to a point, said point being 40.00 feet left of the centerline of Short Street at station 9+25.00;
- 3) **Thence**, across the grantor's tract, **South 78 degrees 11 minutes 25 seconds West, 78.53 feet** to a point on the grantor's west line and said east line of the 44.960 acre tract, said point being 45.00 feet left of the centerline of Short Street at station 10+02.56;

- 4) **Thence**, along the grantor's west line and the east line of said 44.960 acre tract, **North 16 degrees 10 minutes 37 seconds West, 20.17 feet**, to the **TRUE POINT OF BEGINNING**, containing 0.033 acres.

It is understood that the parcel of land described contains, 0.033 acres, more or less, including the present road occupies 0.000 acres, more or less and is located in Franklin County Auditor's Parcel Number 010-274085.

All iron pins set are 5/8 inch x 30 inch rebar with a 1 inch plastic cap stamped "2LMN, Inc".
