5. A description of work performed to date as part of the contract and a full description of work to be performed during any future phasing of the contract.

This contract provides professional design services and services during construction for the Fairwood Facility Improvements project. This contract will assess the current Fairwood Facility conditions, needed improvements, and evaluate the existing emergency power system and document it in a report. The project currently has three construction contracts planned to be performed.

The first construction contract, F31 - HVAC Improvements, will remove and replace a rooftop Air Handler Unit on the existing building and one boiler on the building's mezzanine. The bids for this contract were received on May 6, 2009.

The second construction contract, F34 – Building Improvements, will replace the existing second story brick fascia with metal siding and related tasks. The construction contract is ready to bid, but is on hold due to funding constraints.

The third construction contract, F35, will replace and upgrade the existing vehicle fueling facilities at the Fairwood Facility and at the Utilities Complex at 910 Dublin Road. This contract's bid opening is planned for the Fall, 2009.

The emergency power system evaluation report will determine the need and scope of any improvements required and if an additional construction contract will be necessary for any upgrades of this system.

The actual emplacement of the designed work will be by construction contract. This contract modification will provide additional preliminary and detailed design and bidding assistance for Contract F34, and the construction-phase engineering services for Contracts F31.

Design services have been completed for Contracts F31 and F34, but continue for the remaining portions of the work. The construction of Contract F31 is ready to proceed.

This contract shall be funded by incremental appropriation, through the use of modifications. The future needs for Services During Construction are anticipated to occur late in 2009 and early 2010, for Contracts F34 and F35, at which time future modifications are planned.

6. An updated contract timeline to contract completion.

The Design Professional (DP) began Preliminary Design after the Notice to Proceed was issued on December 15, 2008.

The DP was directed to prepare contract documents for the HVAC Improvements, F31 on April 2, 2009. The design was completed and the construction contract bids were received on May 6, 2009. The construction work will be placed under contract as soon as possible, and the construction services will commence. The construction contract's final completion is expected 120 days from the date that a Notice To Proceed (NTP) is given by the City.

The DP provided the results of the Fairwood building evaluation and required improvements on April 17, 2009. The design for Building Improvements, F34 was completed and the construction contract bidding was placed on hold. After the contract is bid, the construction work will be placed under contract as soon as possible, and the construction engineering services will commence. The construction contract's final completion is expected 180 days from the date that a Notice To Proceed (NTP) is given by the City.

The DP is preparing the contract documents for Contract F35 for the replacement and upgrade of the existing vehicle fueling facilities at the Fairwood Facility and at the Utilities Complex at 910 Dublin Road. This contract's bid opening is planned for Fall, 2009. The construction work will be placed under contract as soon as possible, and the construction engineering services will commence.

After the emergency power system evaluation report is received and reviewed, it will be determined if an additional construction contract will be necessary for any upgrades of this system.

This is the first modification for this contract.

PROPOSED MODIFICATION NO. 1: \$51,394.00

This modification provides \$26,433.00 of funding for additional Preliminary and Detailed Design services that became necessary in the course of the design development and \$24,961.00 of funding for Services During Construction tasks for Contract F31.

This Contract Modification No. 1 was planned and anticipated, and so stated in the original contract's legislation. It is a planned continuation of the services originally included within the existing contract's scope of service.

The funding provided by this contract modification is for continuation of the existing work of the contract.
