Thence South 68° 13' 01" East a distance of 3871.42 feet to a centerline monument set at the centerline right-of-way intersection of Petzinger Road (Station 37+02.68) and Courtright Road (Station 41+62.20);

Thence South 04° 29' 48" West a distance of 351.83 feet along centerline of Courtright Road (R/W width varies) to a point at centerline Station 38+10.38 and being the **TRUE POINT OF BEGINNING** for the parcel herein described;

Thence South  $04^{\circ}$  29' 48" West a distance of 114.34 feet along the centerline of Courtright Road, to the southeasterly corner of said 1.020 acre tract on the centerline station 36+96.03;

Thence North 04° 29' 48" East a distance of 114.34 feet to an iron pin set on the southerly line of a 0.980 acre tract conveyed to Community Housing Intent, INC. by deed of record in Instrument Number 202207070099754 and the northerly line of said 1.020 acre tract, 30.00 feet left of the centerline station 38+10.39

Thence South 85° 28' 51" East a distance of 30.00 feet along the line common to said 1.020 acre tract and said 0.980 acre tract to the **TRUE POINT OF BEGINNING**, containing 0.079 acres, more or less, of which the present road occupies 0.052 acres and being subject to all easements, restrictions, and right-of-way of record.
