[Surveyor's description of the premises follows]

Situate in Half Section 41, Township 5N, Range 22W, Scofield's Survey of the Refugee Lands, in the City of Columbus, County of Franklin, State of Ohio, and being part of a 0.179 acre tract of land as conveyed to John L. Marbury and Rebecca P. Marbury by deed recorded in Instrument No. 200402050026273 (all references to deeds, microfiche, plats, surveys, etc. refer to the records of the Franklin County Recorder's Office, unless noted otherwise) and being more particularly bounded and described as follows:

COMMENCING FOR REFERENCE at the southeast corner of said 0.179 acre tract, said point being the intersection of the north right of way line of Markison Avenue (38' public right of way), being the north line of a 10' easement ROW conveyed to Frederick Babbert in Deed Book 46, Page 248, with the west right of way line of 17th Street (38' public right of way) conveyed to the City of Columbus in Deed Book 626, Page 572, 21.75 feet left of centerline Station 80+38.04, thence along the east line of said 0.179 acre tract and the west right of way line of 17th Street North three degrees thirty-two minutes forty-four seconds East (N03°32'44"E), for twelve and 50/100 feet (12.50') to an iron pin set 21.75 feet left of centerline Station 80+50.5, said iron pin being the POINT OF BEGINNING;

thence leaving said lines across said 0.179 acre tract, South forty-two degrees fourteen minutes thirty-three seconds West (S42°14'33"W), for eleven and 60/100 feet (11.60') to a point, 29.00 feet left of centerline Station 80+41.49;

thence continuing across said 0.179 acre tract, North three degrees thirty-two minutes forty-four seconds East (N03°32'44"E), for seventeen and 37/100 feet (17.37') to a point, 29.00 feet left of centerline Station 80+58.86;

thence continuing across said 0.179 acre tract, South eighty-six degrees twenty-seven minutes sixteen seconds East (S86°27'16"E), for seven and 25/100 feet (7.25') to a point on the east line of said 0.179 acre tract and the west right of way line of said 17th Street, 21.75 feet left of centerline Station 80+58.86;

thence along said lines, South three degrees thirty-two minutes forty-four seconds West (S03°32'44"W), for eight and 32/100 feet (8.32') to the POINT OF BEGINNING.

The above described area contains 0.002 acres (93.15 sq. ft.), more or less, of which the present road occupies 0.000 acres, more or less, which is part of the Franklin County Auditor's Permanent Parcel Number 010-077846.

The stations and offsets of the above description are measured from the proposed centerline of construction for 17th Street.

Iron pins set are 5/8" rebar, 30" in length, with a plastic plug placed on top inscribed with the name "WOOLPERT INC", unless otherwise noted. All monuments found are in good condition unless otherwise noted.

The bearings shown hereon are based on the centerline of Ann Street from Frebis Avenue to Whittier Street as being North 03° 44' 35" East, from an adjusted field survey using multiple VRS observations and/or direct GNSS measurements from Franklin County monuments FRANK 43, 973, and Continually Operating Reference Station (CORS) COLB, based on the Ohio State Plane Coordinate System, South Zone, and North American Datum of 1983 (NSRS 2007) scaled to ground by 1.0000488019 about the projection false northing and easting (0, 1968500).

This description was prepared under the direction of Cody Schneider, Ohio Registered Surveyor No. 8670, of Woolpert Inc., based upon a field survey performed during June, 2019.
