[Surveyor's description of the premises follows]

Situated in the State of Ohio, Franklin County, City of Columbus, U.S. Military Lands, Quarter Township 3, Township 1, Range 17, being a 0.528 acre tract as conveyed to Dianne A. Farington. Prior instrument reference as of the date this survey was prepared: Official Record 02063, Page F06 and Deed Book 3210, Page 456, of the Recorder's Office, Franklin County, Ohio. Being bounded and described as follows:

Commencing at a point at the intersection of the southerly standard highway easement line of Mock Road (60' wide) as established and accepted by the Commissioners of Franklin County in Road Record 7, Page 82, said point also being on the westerly property line of a 0.914 acre tract as conveyed to Dianne A. Phares in Instrument Number 200112110288880, said point being referenced by an ¾" iron pipe found 30.15' right of the Mock Road centerline station 63+80.24, said point also being on the easterly property line of said Dianne A. Farington tract, being 30.00' right of the Mock Road centerline station 63+80.68 and being the **True Point of Beginning**;

Thence S 03°45'30" W a distance of 26.93' leaving the southerly standard highway easement line and along the westerly property line of said Dianne A. Phares tract to a point, being 56.93' right of the Mock Road centerline station 63+80.66;

Thence S 85°10'18" W a distance of 23.36' leaving the westerly property line of said Dianne A. Phares tract and through said Dianne A. Farington tract to a point, being 60.40' right of the Mock Road centerline station 63+57.56;

Thence N 22°44'31" W a distance of 33.96' continuing through said Dianne A. Farington tract to a point on the southerly standard highway easement line of said Mock Road, being 30.00' right of the Mock Road centerline station 63+42.43;

Thence S 86°17'30" E a distance of 38.25' along the southerly standard highway easement line of said Mock Road to the **True Point of Beginning**;

The above described area contains 0.0205 acres of land, more or less, of which the present road occupies 0.000 acres of land, being part of Franklin County Auditor's Parcel Number 010-167511.

All references here in are to records in the Recorders Office, Franklin County, Ohio.

Grantor claims title by Official Record 02063, Page F06 and Deed Book 3210, Page 456.

The basis of bearings for this description are based Geodetic North of the Ohio State Plane Coordinate System, South zone, NAD83 (2011) as determined from GPS observations utilizing the ODOT RTN with the centerline of Right-of-Way of Mock Road being S 86°17'30" E.

All stations and offsets here in are referenced to the centerline of existing right-of-way of Mock Road as shown upon the right-of-way plan "Improvements of Alum Creek Trail Mock Road Connector from E. Hudson Street and Parkwood Avenue to Existing Alum Creek Trail at Sunbury Road and Mock Road "on file with the City of Columbus, Ohio.
