This RP does not have any Fleet approval attached. Typically I would reject it back to the agency, but since the RP is from 2013 I don't know if that would cause any issues in our system.

Please do the following and let me know when the RP has been updated:

- Get approval from Fleet for these specs and attach it to the notepad of the RP. Have them confirm that the Sortimo specs are adequate.
- Review and clarify the specifications. If I understand them correctly, it's for two items: a CNG conversion and the purchase and installation of Sortimo Flooring and Shelving. Please break this into two different lines as we may get two different bidders for this work and we need to split it into two lines so it can be bid separately. Attach the revised specs to the notepad.
