Eastside Neighborhood Stormwater System Improvements - CIP 610758-100000 consists of all labor and materials for the construction of approximately 5,875 feet of 12-inch storm sewer pipe, 54 standard catch basins, 20 type C standard manholes, 1 type E standard manhole, 5 curb and gutter inlets, 653 feet of 4-inch underdrain and other such work as may be necessary to complete the contract, in accordance with the plans CC-15985 and specifications.

Contract work is required to be completed in a manner acceptable to the City within 365 days from the date that a Notice To Proceed (NTP) is given by the City.

This project was initiated in response to documented roadway and property flooding affecting residents throughout the City of Columbus.
