The purpose of this project is to construct necessary improvements to the water distribution system in the Silver Drive area. The improvements identified in the scope of work will replace or rehabilitate water lines that have high break histories and require frequent maintenance. This project includes replacing or rehabilitating approximately 15,665 linear feet of 6-inch and 8-inch and water lines within the project area.

The project area includes Silver Drive, Genessee Avenue, Loretta Avenue, Dresden Street, Godown Road, Weber Road, and East Como Avenue.

6. **A narrative timeline for the contract including a beginning date, beginning and ending dates for known phases of the contract and a projected ending date.**

The duration of the design phase for this project is 12 months. Part of the Engineer's contract is to provide Record Drawings after the construction of this project. Therefore, the contract completion date cannot be determined at this time

7. **A narrative discussing the economic impact or economic advantages of the project; community outreach or input in the development of the project; and any environmental factors or advantages of the project.**

The goal of this project is to replace or rehabilitate the existing 6-inch and 8-inch water lines that have a high break frequency. Replacement of these water lines will decrease burden on water maintenance operations. The new lines constructed under this project should eliminate the pattern of frequent water line breaks and reduce water loss.
