Hey boss,

For what it's worth, ~166k was Altec's original bid price for the UTC, and we were able to get it whittled down to 157k.

Also, our most recent 37' bucket truck for the Electronics section cost approx. 178k – so we are already seeing savings with this UTC.

Likewise, the 50' trucks were originally bid out around ~280 and we were able to get it whittled down to 249k.

A great effort by the team to not only get the trucks that they want but for a very competitive price!
