RE: INTEGRATING PUBLIC WARRIOR WATCH APPLICATION INTO MY COLUMBUS

Dear Ms. Elhami:

On behalf of the City of Columbus Department of Public Service (DPS) and Department of Technology (DoT) T&M successfully developed the Warrior Watch web application (<a href="http://warriorwatch.columbus.gov">http://warriorwatch.columbus.gov</a>) using HTML 5 and JavaScript. The application allows citizens of Columbus to view which streets have received snow and ice treatment in real-time and check snow removal priority designations for City of Columbus streets.

### **SCOPE OF SERVICES**

# Task 1: Application Maintenance, Documentation, & General Support - \$12,210

T&M will support DoT staff by performing general maintenance on the existing data sets and server side processes for Warrior Watch (Public Release Only). T&M GIS staff will work with DoT staff to properly document existing data workflow and future maintenance procedures (Internal and Public Warrior Watch). T&M will provide this support on an hourly basis and estimates approximately 80 hours of support.

Examples of support tasks include:

- Monitoring system performance during peak operations.
- Onsite meetings and support.
- Generating documentation of data workflow and maintenance procedures.
- Generating documentation of public warrior watch application deployment and configuration in addition to T&M's previously delivered application maintenance plan.

### **Task 2: Assumptions**

- T&M will provide application maintenance, documentation, and general support services on an hourly basis. Please see included hourly rate table for key staff.
- T&M will require access to City of Columbus servers either in person or via remote access.



## Task 2: Application Maintenance, Documentation, & General Support Contingency -\$15,000

T&M will notify DoT staff when the labor expenditure reaches 90% of the total estimate for Task 1. In the event of any unforeseen circumstances occurring, a contingency amount of \$15,000 is being identified. No work will be done utilizing the contingency funds as identified unless approved and authorized by the appropriate City of Columbus authority.

### **COST & SCHEDULE**

A cost table and schedule for completing the scope of work is provided in Table 1:
