[Surveyor's description of the premises follows]

Situate in the State of Ohio, County of Franklin, City of Columbus, being located in Half Section 50 in original Truro Township, Township 12, Range 21 of the Refugee Lands. The herein described parcel lies on the left side of the existing centerline of right-of-way of Refugee Road. All bearings and distances, stations and offsets are based on the Right-of-Way plans prepared by Burgess & Niple for the City of Columbus as shown on the centerline plat for Refugee Road as recorded in Plat Book 125, pages 58 – 61 of the Franklin County Recorder's Office and as on file with the City of Columbus in plan 3419-E. Being part of lands conveyed to the "EASTLAND MALL HOLDINGS, L.L.C., A DELAWARE LIMITED LIABILITY COMPANY" (hereafter referred to as Grantor) as described in Instrument No. 201505010056380 of the Franklin County Recorder's Office and being more particularly described as follows:

**COMMENCING** at 60.00 feet left of the existing centerline of Right-of-way of Refugee Road at station 93+84.42 and the **TRUE POINT OF BEGINNING** of the herein described parcel;

**THENCE North 46 deg. 53 min. 51 sec. East** for a distance of **3.77 feet** to 62.77 feet left of the existing centerline of right-of-way of Refugee Road at station 93+86.96;

**THENCE South 88 deg. 09 min. 31 sec. East** for a distance of **12.98 feet** to 63.35 feet left of the existing centerline of right-of-way of Refugee Road at station 93+99.96;

**THENCE South 86 deg. 42 min. 00 sec. East** for a distance of **150.00 feet** to 66.20 feet left of the existing centerline of right-of-way of Refugee Road at station 95+49.91;

**THENCE South 85 deg. 40 min. 59 sec. East** for a distance of **105.03 feet** to 66.33 feet left of the existing centerline of right-of-way of Refugee Road at station 96+54.94;

The above-described parcel contains 0.110 acres total, including 0.000 acres in the present road occupied (PRO), lying in Franklin County Auditors parcel number 010-283244.

The basis of bearings for the above-described parcel are based on the Grid North and the Ohio State Plane Coordinate System, South Zone, NAD83(2011), as established from a GPS survey utilizing the Ohio Department of Transportation's Virtual Reference System (VRS), performed by OHM-Advisors in November, 2015 and as expressed on said Right-of-Way plans and Centerline Plat prepared by Burgess & Niple for the City of Columbus on the existing centerline of Refugee Road by a monument box, located at the center of the box lid, at station 10+00.00

and a 1” rebar set in pavement at the centerline intersections of Refugee Road and Schwartz Road at station 28+89.33 with a bearing of South 85 deg. 43 min. 08 sec. East.
