Situated in the State of Ohio, County of Franklin, City of Columbus, Section 26, ½ Section 39, Township 5, Range 22, Refugee Lands, being a strip of land located within those three tracts described in deeds to The City National Bank and Trust Company of Columbus, of record in Deed Volume 2545, Page 498 (north tract, 0.5 acre), Deed Volume 2546, Page 280 (middle tract, 0.784 acre less south 40 feet) and Deed Volume 2546, Page 277 (south tract, 40 foot wide strip), all references being to the records of the Recorder's Office, Franklin County, Ohio, said strip being on the RIGHT side of Lockbourne Road (and north of S.R. 104) as delineated upon plans prepared for the City of Columbus and designated as 2746 DR. E, and being more particularly described as follows:

All references herein to station and offset are to the centerline of construction of Lockbourne Road.

Beginning at the intersection of the southerly line of said south tract and the easterly right-of-way line of Lockbourne Road located 30.00 feet RIGHT of station 73+16.36;

Thence North 03°54'25" East, along said right-of-way line, a distance of 357.70 feet to the intersection of the southerly right-of-way line of Moler Road, 30.00 feet in width, located 30.00 feet RIGHT of station 76+74.06:

Thence South 85°30'36" East, along said right-of-way line, a distance of 13.00 feet to a point located 43.00 feet RIGHT of station 76+73.92;

Thence through said three tracts the following courses:

- 1. South 03°54'25" West, a distance of 8.00 feet to a point located 43.00 feet RIGHT of station 76+65.92;
- 2. South 30°35'16" West, a distance of 17.82 feet to a point located 35.00 feet RIGHT of station 76+50.00;
- 3. South 03°54'25" West, a distance of 333.67 feet to a point in the southerly line of said south tract located 35.00 feet RIGHT of station 73+16.34;

Thence North 85°50'57" West, along said southerly line, a distance of 5.00 feet to the place of beginning.

Containing 0.0440 acre of land, of which the present road occupies 0.0000 acre leaving a net take of 0.0440 acre, 0.0046 in parcel no. 010-113473, 0.0215 acre in parcel no. 010-112419 and 0.0179 acre in parcel no. 010-112357.

Bearings herein are based on field observations of established control points from the Franklin County Engineers Office, resulting in a bearing of North 03°54'25" East, for the existing centerline of Lockbourne Road north of Marion Road.
