SUBJECT: Land Application of Biosolids Bid Recommendation SA003896

Find attached two original bids opened Wednesday March 30, 2011. I recommend that the Division award Bid Items 1 through 5 to Synagro Central, LLC, 7014 East Baltimore Street, Baltimore, MD 21224 for \$650,000. This should fund the contract from August 1, 2011 until March of 2012.

Funds for the contract are available from Jackson Pike WWTP Index OCA 605022 Object Level 3419 in the amount of \$300,000. Southerly WWTP has \$350,000 in OCA 605055 Object Level 3419 to fund landfill disposal of sewage sludge and incinerator ash. This is the first year of a multi-year contract allowing two (2) one-year contract extensions upon mutual consent of the City and the contractor.
