[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, City of Columbus, being part of Section 2 of Township 12, Range 21 Refugee Lands, part of Quarter Township 3, Township 1, Range 16, United States Military Lands, and being part of a 21.416 acre tract of land in the name of Mount Carmel Health, an Ohio not for profit corporation, formerly known as The Hawkes Hospital of Mt. Carmel, Franklin County, Ohio, as described in Official Record 16070 Page D16, all records are on file in the Franklin County Recorder's Office, and being a tract of land lying on the right side of the centerline of Right of Way of State Route 16 (East Broad Street), hereafter referred to as S.R. 16, as shown on the FRA-16-7.79 and FRA-270-30.32 plans made by the Ohio Department of Transportation, and is more particularly described as follows:

Beginning for Reference at a concrete monument found in the southerly Right of Way line of said S.R. 16 (East Broad Street), being 33.00 feet right of centerline Station 205+00.00 as delineated in the FRA-16-7.79 centerline plat as recorded in Plat Book 29, Page 4;

Thence North 08°08'48" West, perpendicular to and leaving said southerly Right of Way line a distance of 33.00 feet to a point in said centerline, being centerline Station 205+00.00;

Thence with said centerline, the following two (2) courses:

1. South 81°51'12" West, a distance of 692.00 feet to a monument box set at a point of deflection at centerline Station 198+08.00;
2. South 82°20'12" West, a distance of 1007.73 feet, passing a monument box set at the centerline of Right of Way intersection of said S.R. 16 (East Broad Street) and McNaughten Road (R/W Varies) at centerline Station 192+01.64 at 606.36 feet, to a point of deflection at centerline Station 188+00.27, being a point in the southerly line of a 43.837 acre tract of land in the name of Mount Carmel Health System, an Ohio Nonprofit Corporation as described in IN. 200312110392742;

Thence South 82°20'12" West, with said southerly line, a distance of 1131.15 feet, to a point being 14.81 feet left of centerline Station 176+68.77 of the centerline of Right of Way of FRA-270-30.32 as shown in Plat Book 40 Page 119-A, being the northeasterly corner of said 21.416 acre tract and a northerly corner of a 46.848 acre tract of land in the name of Hawkes Hospital of Mt. Carmel as described in Deed Book 589, Page 648;

Thence South 09°45'35" East, a distance of 100.07 feet with the easterly line of said 21.416 acre tract to a point in the southerly Right-of-Way line of S.R 16 (East Broad Street), being 85.26 feet right of centerline Station 176+68.21, and the **True Place of Beginning** for the tract of land herein being described;

Thence with the easterly line of said 21.416 acre tract, the following two (2) courses:

1. South 09°45'35" East , a distance of 10.65 feet to a point being 95.91 feet right of centerline Station 176+68.15;
2. South 01°41'17" West, a distance of 30.34 feet to a point being 125.61 feet right of centerline Station 176+62.02;

Thence South 82°20'12" West, through said 21.416 acre tract, a distance of 50.68 feet to a point in the westerly line of said 21.416 acre tract, being 123.59 feet right of centerline Station 176+11.86;

Thence North 01°41'17" East, with said westerly line, a distance of 28.48 feet to a point being 95.69 feet right of centerline Station 176+17.51;

Thence through said 21.416 acre tract, the following two (2) courses:

1. North 82°09'00" East, a distance of 7.55 feet to a point 95.95 feet right of centerline Station 176+25.00;
2. North 09°52'58" West, a distance of 12.46 feet to a point in said southerly Right of Way line, being 83.49 feet right of centerline Station 176+25.00;

Thence North 82°20'12" East, with said southerly Right of Way line, a distance of 43.52 feet to the **True Place of Beginning**.

The above described area contains 0.045 acres, more or less, which is part of Franklin County Auditor's Permanent Parcel number 010-009790-00.

Bearings for this description are based on Ohio State Plane Coordinates, South Zone, NAD 83 (2007) Datum as established utilizing a GPS survey performed in November 2017, holding North 82°20'12" East for the centerline of East Broad Street (State Route 16).

The stations referred to in this description are from the centerline of Right-of-Way of State Route 16, as found on the FRA-16-7.79 centerline plat as recorded in Franklin County Recorder's Office in Plat Book 29, Page 4, and the FRA-270-30.32 centerline plat as recorded in Franklin County Recorder's Office in Plat Book 40 Page 119-A.

The stations are shown on the FRA 16 8.24 centerline plat, as recorded in Franklin County Recorder's Office in Plat Book 132 Page 106-109.
