The work for which proposals were invited consists of construction of approximately 119 feet of 12-inch watertight sanitary sewer; 249 feet of 15-inch watertight sanitary sewer; 296 feet of 24-inch watertight sanitary sewer; 632 feet of 30-inch watertight sanitary sewer; 8 manholes; 9 curb and gutter inlets and catch basins; cementitious manhole rehabilitation; manhole frame and cover replacement, and other such work as may be necessary to complete the contract in accordance with the plans (CC-16002) and specifications.

6. **A narrative timeline for the contract including a beginning date, beginning and ending dates for known phases of the contract and a projected ending date.**

All work shall be completed within 270 Calendar days of the Notice to Proceed.

7. **A narrative discussing the economic impact or economic advantages of the project; community outreach or input in the development of the project; and any environmental factors or advantages of the project.**

This project will redirect stormwater runoff from the existing combined sewer system to the Olentangy River. This will reduce the peak in the combined sewer and help to reduce CSO overflows at the First Ave Regulator, as required per the 2005 WWMP. A public meeting was held in April of 2012 to inform the local residents of the impacts to their neighborhood due to the upcoming construction activity.

No modifications are anticipated.
