This memorandum is a recommendation for construction contractor selection and processing the construction legislation for the Pedestrian Safety Improvements – King Avenue-NW Boulevard-Worthington Woods Boulevard sidewalks project.

#### Project Scope:

This project will construct sidewalks and associated handicap ramps on King Avenue-Westwood Avenue to Andover Street (0.2 miles) & Northwest Boulevard-King Avenue to 5<sup>th</sup> Avenue (0.2 miles) and Worthington Woods Boulevard-Alta View Boulevard to Sancus Boulevard (0.38 miles); Drives will be replaced as needed to meet ADA requirements.

Fiscal Impact: Source of funds is 2011 SIT Certification.

Engineer's estimate + inspection (20%): \$451,769.34 Low bid amount + inspection (20%): \$363,131.74 Difference between the engineer's estimate and bid amount, including inspection: \$88,637.60

<u>Schedule:</u> Bids were opened June 14, 2011; estimated Council date is July 11, 2011; estimated NTP date is August 3, 2011. The contract has a completion date of October 31, 2011.

Engineer's Estimate: \$376,474.45

Newcomer Concrete Services has one sub-contractor that is non-compliant, Keller Environmental DBA Keller Farms. Linda Newcomer Holmer was informed of this situation and Ms. Newcomer Holmer stated that she would either have the sub-contractor become compliant or would replace the sub-contractor.

#### Recommendation:

With reference to bids received on June 14, 2011, I wish to make the following recommendation for the subject improvement:

Award is made to the lowest responsive and responsible and best bidder, Newcomer Concrete Services, for their bid of \$302,609.78, which is \$73,864.67 under the Engineer's estimate of \$376,474.45.

Newcomer Concrete Services did complete the Construction Contract Subcontractor Report. All of the subcontractors contacted were chosen to be subcontractors on the project.

Please respond to this e-mail indicating approval of the recommended contractor – Newcomer Concrete Services – or approval of another contractor. If you approve another contractor please provide an explanation.
