Situated in the State of Ohio, County of Franklin, City of Columbus, being located in Quarter Township 4, Township 2, Range 17 of the United States Military Lands, being part of Lot 5 of the Plat of Dedan Carter Heirs Lands as recorded in Plat Book 3, Page 102, and being 0.039 acres within a 6.390 acre parcel conveyed to GAHANNA SHOPPING PLAZA, LLC an Ohio limited liability company, as described in Instrument Number 201511240165767 and being more particularly described as follows:

Being a parcel of land lying on the left side of the centerline of a survey made for project Hamilton Road, made by the Department of Transportation, and being located within the following described points in the boundary thereof:

Commencing for reference at Franklin County Geodetic Survey (FCGS) monument #8813 found in the centerline of Hamilton Road (120' R/W), being at Station 111+37.26 and being South 3°07'54" West a distance of 1544.04 feet, along the centerline of right-of-way of Hamilton Road, from Franklin County Geodetic Survey (FCGS) monument #8814 found;

Thence from the said FCGS #8813 and along the said centerline of right-of-way of Hamilton Road, North 3°07'54" East a distance of 765.88 feet to a point at Station 119+03.14;

Thence across the lands North 86°52'06" West a distance of 60.00 feet to an iron pin set on the existing westerly right-of-way line of Hamilton Road and the westerly line of a tract conveyed to the City of Columbus in Instrument Number 200307310242157, being 60.00 feet left of Station 119+03.14 and the True Point of Beginning;

Thence across the said 6.390 acre tract, North 44°32'08" West, a distance of 61.92 feet to an iron pin set and being 105.78 feet left of centerline Station 119+44.84;

Thence across the said 6.390 acre tract, North 86°52'06" West, a distance of 36.84 feet to an iron pin set and being 142.62 feet left of centerline Station 119+44.84;

Thence across the said 6.390 acre tract, North 3°07'54" East a distance of 10.00 feet to an iron pin set on the existing southerly right-of-way line of Menerey Lane (as dedicated in Plat Book 86, Page 6) and being 142.62 feet left of centerline Station 119+54.84;

Thence along the existing southerly right-of-way line of Menerey Lane, South 86°51'50" East a distance of 62.62 feet to an iron pin set and being 80.00 feet left of centerline Station 119+54.84;

Thence along the said southerly existing right-of-way line of Menerey Lane with a curve to the right having a radius of 20.00 feet, a central angle of 89°58'58", an arc length of 31.41 feet, and a chord that bears South 41°52'06" East a distance of 28.28 feet to an iron pin set at 60.00 feet left of Station 119+34.84;

Thence along the said westerly right-of-way line of Hamilton Road, S 3°07'54" W a distance of 31.70 feet to the True Place of Beginning, containing 0.039 acres, more or less.

The above described parcel contains 0.039 acres, more or less, including the present road occupies, which is 0.000 acres, for a net take of 0.039 acres, from Auditors Permanent Parcel Number 545-280739.

All iron pins set are 5/8 inch rebar (30 inches long) with a yellow plastic cap stamped "R/W Dynotec, Inc." and are to be set after construction.

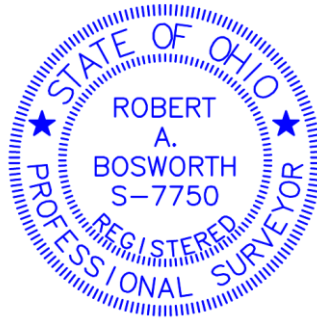

The basis of bearings shown are based on the State Plane Coordinate System, Ohio South, as per NAD 83 (96 CORS) established by Dynotec, Inc. using GPS procedures and equipment, which sets the centerline of Hamilton Road as North 3°07'54" East.

The stations referred to herein are from the centerline of right-of-way of Hamilton Road as found on O.D.O.T. right of way plan "Hamilton Road" on file with the Ohio Department of Transportation, District 6, City of Delaware, Delaware County, State of Ohio.
