**The original contract for the provided for engineering design and Modification No. 1 provided for construction administration services for separate chlorine storage feed system. Upon further consideration regarding safety concerns following the events of September 11, 2001, the Department of Public Utilities decided to redesign this system to utilize a different disinfection chemical in lieu of gaseous chlorine. In addition to the disinfection facility redesign services; this contract includes design services for a chlorine scrubber installation which is a temporary measure as the Dublin Road Water Plant is being redesigned to utilize a different disinfection chemical in lieu of gaseous chlorine.**

An explanation of why the work to be performed as part of the contract modification cannot be bid out. (Indicating the work to be a logical extension of the contract is not sufficient explanation)

**Due to consideration regarding safety concerns following the events of September 11, 2001, it was determined that modifying the contract and continuing the work with the previously selected consultant would expedite the work and implement installation of the temporary scrubber as soon as possible, as well as installing the new disinfection facility in the shortest timeline.**
