Situated in the City of Columbus, Franklin County, State of Ohio, and being part of Quarter Township 4, Township 2, Range 19 United States Military Lands, and being part of Lot 129 of The Gables West Subdivision as recorded in Plat Book 43, page 78 in the Franklin County Recorder's Office. Lot 129 being transferred to John Weston in instrument number 201706210084043 in the Franklin County Recorder's Office:

COMMENCING for reference at a point at the southeast corner of said Lot 129 and the northeast corner of Lot 130 said point being 40.00 feet left of centerline of existing right of way for Godown Road stationing 9+69.72 and being the **TRUE POINT OF BEGINNING** for the parcel herein described:

**Thence**, along the south line of said Lot 129 and the north line of said Lot 130, **North 86 degrees 24 minutes 14 seconds West, 15.00 feet** to a point, said point being 55.00 feet left of centerline of existing right of way for Godown Road stationing 9+69.72;

**Thence**, across the grantor's tract, **North 03 degrees 39 minutes 01 seconds East, 5.00 feet** to a point, said point being 55.00 feet left of centerline of existing right of way for Godown Road stationing 9+74.72;

**Thence**, across the grantor's tract, **North 48 degrees 03 minutes 59 seconds East, 21.41 feet** to a point on the east line of said Lot 129 and the west existing right of way for Godown Road, said point being 40.00 feet left of centerline of existing right of way for Godown Road stationing 9+90.00;

**Thence**, along the east line of said Lot 129 and the existing right of way of Godown Road, **South 03 degrees 35 minutes 46 seconds West, 20.28 feet** to the **TRUE POINT OF BEGINNING**, containing 0.004 acres.

It is understood that the parcel of land described contains, 0.004 acres, more or less, including the present road occupies, 0.000 acres, more or less, is located in Franklin County Auditor's permanent parcel number 010-157403-00.

All iron pins set are 5/8" x 30" rebar with orange plastic caps stamped "2LMN".

All stations and offsets referred to herein are measured from the centerline of existing right-of-way of Godown Road as dedicated with Portage Grove Addition Extension No. 1 Subdivision as shown in Plat Book 29, Page 5 and the Gable West Subdivision as shown in Plat Book 43, Page 78 in the Franklin County Recorder's Office.

The basis of bearings herein are based upon the centerline of Godown Road being North 03 degrees 35 minutes 46 seconds East, from Ohio State Plane Coordinate System (Ohio South Zone, NAD 83 (2011)). Beginning at the point of tangent at station 8+22.03 in the intersection of Portage Road and Godown Road thence north through the project.
