Ord. 1867-2005, passed November 21, 2005, authorized an increase in the contract amount in order to cover the Division's needs for 2005. The contract document number for that modification was EL005690.

This modification is solely for the purpose of increasing the funding for the purchase of power line clearance (tree trimming) services during the remaining term of the contract through March 2007. There is no modification to the terms or scope of the contract.

This modification will provide funding from the 2006 operating budget for services rendered during the remaining term of the contract.

The City has contracted with Asplundh Tree Expert Company to provide power line clearance services through March 2007. There is no change in the scope of the contract.
