Thence **North 04 degrees 26 minutes 27 seconds East**, along the proposed east right-of-way line for said James Road and across said Lot 11, a distance of **50.00 feet** to an iron pin set on the north line of said Lot 11, being the south line of Lot 12 of said Easthampton Addition, as said Lot is described in a deed to Donald E. Tate, of record in Official Record 14844, page H19, said iron pin set being 38.05 feet right of James Road proposed centerline of construction Station 114+77.93;

Thence South 85 degrees 33 minutes 33 seconds East, along the north line of said Lot 11 and along the south line of said Lot 12, a distance of 20.38 feet to a point, said point being 58.43 feet right of James Road proposed centerline of construction Station 114+77.93;
