This memorandum is a recommendation for construction contractor selection and processing the construction legislation for the, Arterial Street Rehabilitation – Lockbourne Road/Groveport to SR 104 and Lockbourne Road Area Assessment Sewer.

<u>Project Scope</u>: The location of the project is Lockbourne Road from S.R. 104 to Groveport Road; Koebel Road from Lockbourne Road to Fairwood Avenue; Evergreen Road east of Lockbourne Road for a distance of approximately 1000 feet. The project will widen Lockbourne Road to three lanes; construction new curbs, curb ramps, bicycle lanes, storm sewerage, water lines, and lighting. A new sanitary system will also be installed.

<u>Fiscal Impact:</u> Funding will be split between Department of Public Service's Division of Design and Construction and Department of Public Utilities Divisions of Stormwater, Sanitary, and Water.

<u>Schedule:</u> Estimated pre-con meeting date and issuance of NTP and NOC is December 29, 2009. Contract is 519 days, to be completed by June 1, 2011. The roadway is to be completely and open to traffic no later than November 12, 2010.

Construction Cost:

The Engineer's Estimate is \$6,772,742.25 (Alternate A).
