
## THE VILLAGE AT ABBIE TRAILS

STATE OF OHIO, COUNTY OF FRANKLIN, CITY OF COLUMBUS SECTION 6, TOWNSHIP 15, RANGE 20, CONGRESS LANDS



MOTE "A": THE 3.254 ACRE TRACT OF LAND SHOWN HEREON IS LOCATED IN ZONE X (AREAS DETERMINED TO BE OUTSIDE 500—YEAR FLOOD PLAIN) AND ZONE "AE" (WITH PORTIONS REMOVED BY LOMR-F AS SUBMITTED IN CASE NO. 13-05-2501A AND 17-05-1969A) AS SHOWN ON THE FLOOD INSURANCE RATE MAP OF THE COUNTY OF FRANKLIN, OHIO COMMUNITY PANEL 39049C0366K DATED: JUNE 17, 2008 AND COMMUNITY PANEL 39049C0368K DATED: JUNE 17, 2008.

NOTE "B": NO DETERMINATION HAS BEEN MADE BY THE DEPARTMENT OF BUILDING & ZONING SERVICES, CITY OF COLUMBUS, AS TO WHETHER THE AREA PROPOSED TO BE PLATTED CONTAINS AREA(S) THAT COULD BE CLASSIFIED AS WETLANDS BY THE ARMY CORP. OF ENGINEERS. IT IS THE DEVELOPER'S RESPONSIBILITY TO DETERMINE WHETHER WETLANDS EXIST ON THE SITE. CITY OF COLUMBUS APPROVAL OF THE FINAL PLAT OF THE VILLAGE AT ABBIE TRAILS SECTION 6 DOES NOT IMPLY ANY APPROVAL FOR THE DEVELOPMENT OF THE SITE AS IT MAY PERTAIN TO WETLANDS.
