



Amendment No. 1
to
Enterprise License Agreement (ELA)
between
Environmental Systems Research Institute, Inc. (Esri)
and
City of Columbus (City)
Esri Agreement No. 2011ELA8423

This Amendment No. 1 modifies the above referenced Agreement as follows:

Enterprise License Terms and Conditions, E512.

1. **Article 1 – Definitions.** Add the following definition:
"Unit Priced Item(s) means separately orderable Software, Data, Web Services, or maintenance that is available subject to a per-unit license fee, subscription fee, or maintenance fee.
2. **Article 2 – Grant of License.**
Section 2.1, Grant of License. Modify the last sentence as follows:
Unit-Priced Items, if acquired and Rolled-In Software will be licensed in accordance with the License Agreement.
3. **Article 4 – Maintenance.** Add Section 4.2:
4.2. Maintenance for Unit-Priced Items. Annual maintenance fees for Unit-Priced Items are not included in the ELA Fee, and, if ordered, additional fees will apply.
4. **Article 5 – Ordering, Administrative Procedures, Delivery, and Deployment.**
Section 5.1, Orders, Delivery, and Deployment. Add new subsections (e) and (f):
(e) Purchase Orders for Unit-Priced Items may be issued by City during the term of this ELA and will shipped to the ship-to address identified in Appendix D, FOB destination or made available via Esri online services.
(f) The following information will be included in each purchase order:
 - (1) Esri customer number and the ship-to address as identified in Appendix D.
 - (2) Purchase order number.
 - (3) Applicable annual payment due, or, for Unit-Priced Items, the quantity, description, price, and name of Licensee.
 - (4) On the face of the purchase order, print the following statement: "Governed by and subject to Enterprise License Agreement No. 2011ELA8423."
