**PARCEL 20-T
HAMILTON ROAD, PHASE B (S CURVE)
TEMPORARY EASEMENT
TO RECONSTRUCT DRIVE**

Situate in the State of Ohio, County of Franklin, City of Columbus, located in Quarter Township 4, Township 2 N, Range 17 W, United States Military Lands, and being part of the 0.990 acre tract conveyed to Ohio Note Investors, LLC. by deed of record in Instrument Number 201203300044094, records of the Recorder's Office, Franklin County, Ohio, and being more particularly described as follows;

Beginning for Reference at the Franklin County Engineer's monument box FCGS 8814 in the existing centerline of Right-of-Way of Hamilton Road, being the easterly line of the 1.170 acre tract conveyed to the City of Columbus by deed or record in Instrument Number 200307310242157, at the common corner of the original 40.809 acre tract conveyed to The New Albany Company LLC, by deed of record in Instrument Number 201212310201338 and the 0.320 acre tract conveyed to the City of Columbus by deed of record in Instrument Number 200807100105811; said monument being 7.13 feet left of Centerline Right-of-Way station 126+80.53;

Thence North 03 deg. 12 min. 47 sec. East, a distance of 44.75 feet, along the existing centerline of Right-of-Way of Hamilton Road and the common line of said original 40.809 and 1.170 acre tracts to a point, being 13.19 feet left of Centerline Right-of-Way station 127+24.47;

Thence North 86 deg. 52 min. 06 sec. West, a distance of 60.00 feet to a point in the existing westerly right-of-way line of Hamilton Road, and the easterly line of the original 2.386 acre tract conveyed to Ohio Note Investors, LLC., by deed of record in Instrument Number 201201040000928, at a southeasterly corner of said 0.990 acre tract, and being the **Point of True Beginning** of the herein described parcel; said point being 72.49 feet left of Centerline Right-of-Way station 127+15.64;

Thence North 86 deg. 52 min. 06 sec. West, a distance of 10.00 feet along the southerly line of said 0.990 acre tract to a point being 82.34 feet left of Centerline Right-of-Way station 127+14.23;

Thence the following two (2) courses and distances across said 0.990 acre tract;

1. Thence North 03 deg. 12 min. 47 sec. East, a distance of 28.21 feet to a point being 86.84 feet left of Centerline Right-of-Way station 127+40.00;
2. Thence North 50 deg. 40 min. 15 sec. East, a distance of 13.57 feet to a point in the existing westerly right-of-way line of Hamilton Road and the easterly line of said 0.990 acre tract: said point being 78.61 feet left of Centerline Right-of-Way station 127+50.00;

Thence South 03 deg. 12 min. 47 sec. West, a distance of 37.37 feet along the existing westerly right-of-way line of Hamilton Road and the easterly line of said 0.990 acre tract to the **Point of True Beginning** of the herein described parcel, containing 0.008 acres (328 sf), more or less, of which 0.000 acres lies within the existing Present Road Occupied.

Of the above described area, 0.008 acres are contained within Franklin County Auditor's Parcel 545-282622-00.

Bearings are based on the existing centerline of Right-of-Way of Hamilton Road being North 03 deg. 07 min. 54 sec. East, as measured using GPS methods from FCGS 8813 to FCGS 8814, based on the Ohio State Plane Coordinate System, South Zone, NAD 83 (NSRS 2007).
