**[Surveyor's description of the premises follows]**

Situate in the State of Ohio, County of Franklin, City of Columbus, being located in Section 4 in original Madison Township, Township 11, Range 21 of the Congress Lands. The herein described parcel lies on the right side of the existing centerline of right-of-way of Refugee Road. All bearings and distances, stations and offsets are based on the Right-of-Way plans prepared by Burgess & Niple for the City of Columbus as shown on the centerline plat for Refugee Road as recorded in Plat Book 125, pages 58 – 61 of the Franklin County Recorder's Office and as on file with the City of Columbus in plan 3419-E. Being part of lands conveyed to the "DULOC HAMILTON LLC, A KENTUCKY LIMITED LIABILITY COMPANY" (hereafter referred to as Grantor) as described in Instrument No. 201612230177495 also of the Franklin County Recorder's Office and being more particularly described as follows:

**COMMENCING** at 60.00 feet right of the existing centerline of right-of-way of Refugee Road at station 106+30.77 and the **TRUE POINT OF BEGINNING** of the herein described parcel;

**THENCE South 85 deg. 36 min. 43 sec. East** for a distance of **204.69 feet** to 60.00 feet right of the existing centerline of right-of-way of Refugee Road at station 108+35.46;

**THENCE South 04 deg. 21 min. 25 sec. West** for a distance of **4.35 feet** to 64.34 feet right of the existing centerline of right-of-way of Refugee Road at station 108+35.46;

**THENCE North 85 deg. 36 min. 43 sec. West** for a distance of **130.04 feet** to 64.34 feet right of the existing centerline of right-of-way of Refugee Road at station 107+05.43;

**THENCE South 04 deg. 23 min. 17 sec. West** for a distance of **10.65 feet** to 75.00 feet right of the existing centerline of Right-of-way of Refugee Road at station 107+05.43;

**THENCE North 85 deg. 36 min. 43 sec. West** for a distance of **74.57 feet** to 75.00 feet right of the existing centerline of Right-of-way of Refugee Road at station 106+30.85;

**THENCE North 04 deg. 04 min. 17 sec. East for a distance of 15.00 feet BACK TO THE TRUE POINT OF BEGINNING.**

The above-described parcel contains 0.039 acres total, including 0.000 acres in the present road occupied (PRO), lying in Franklin County Auditors parcel number 530-138885.

The basis of bearings for the above-described parcel are based on the Grid North and the Ohio State Plane Coordinate System, South Zone, NAD83(2011), as established from a GPS survey utilizing the Ohio Department of Transportation's Virtual Reference System (VRS), performed by OHM-Advisors in November, 2015 and as expressed on said Right-of-Way plans and Centerline Plat prepared by Burgess & Niple for the City of Columbus on the existing centerline of Refugee Road by a monument box, located at the center of the box lid, at station 10+00.00 and a 1" rebar set in pavement at the centerline intersections of Refugee Road and Schwartz Road at station 28+89.33 with a bearing of South 85 deg. 43 min. 08 sec. East.

This description was prepared by Burgess & Niple, under the direct supervision of Michael D. Jones, P.S., Ohio License No. 8459 and is based on a recent survey of the existing boundary monument locations performed by OHM Advisors, under the direction of John Raab, Professional Surveyor, Ohio License Number 7863, under a sub-consultant agreement between Burgess & Niple and OHM Advisors, for said services.
