Commencing for reference at a point on the existing centerline of right-of-way for Flint Road, being the southeast corner of the grantor's land, and being a point the northeast corner of a tract of land conveyed to the Board of Trustees of Sharon Township, of record in Deed Book 1925, page 306, said point being at Flint Road proposed centerline of construction Station 410+24.56;

Thence North 85 degrees 38 minutes 18 seconds West, along the south line of the grantor's land and along the north line of said Sharon Township tract, a distance of 27.92 feet to a point on the existing west right-of-way line for Flint Road, said point being 25.00 feet left of Flint Road proposed centerline of construction Station 410+12.13;

Thence across the grantor's land along the following seven (7) described courses:

North 30 degrees 47 minutes 43 seconds East, along the existing west right-of-way line for said Flint Road, a distance of 18.76 feet to a point, said point being 25.00 feet left of Flint Road proposed centerline of construction Station 410+30.89, and said point being the TRUE **POINT OF BEGINNING** for the herein described sewer easement;

2. North 70 degrees 58 minutes 56 seconds West, a distance of 33.03 feet to a point, said point being 57.33 feet left of Flint Road proposed centerline of construction Station 410+24.15;

- 3. South 82 degrees 51 minutes 10 seconds West, a distance of 19.35 feet to a point, said point being 72.59 feet left of Flint Road proposed centerline of construction Station 410+12.26;
- 4. North 13 degrees 55 minutes 40 seconds East, a distance of 19.85 feet to a point, said point being 78.35 feet left of Flint Road proposed centerline of construction Station 410+31.25;
- 5. North 72 degrees 50 minutes 56 seconds East, a distance of 21.62 feet to a point, said point being 63.87 feet left of Flint Road proposed centerline of construction Station 410+47.30;
