Sir,

The following investigation was conducted concerning the City of Columbus' 2019 annual objection to the renewal of liquor permit **1392586** issued to **Channing Inc.**, which is doing business as **C-One Market** located at **6044 Channingway Boulevard, Columbus, Ohio 43232**. The recorded owner of said permit is **Mohannad Alhiassah**.

After reviewing the State of Ohio, Franklin County, and City of Columbus records regarding the above liquor permit establishment, the following information has been compiled to support the objection to the renewal of the aforementioned permit issued by the State of Ohio.

The above listed liquor establishment has been issued a **C1 and C2** permits by the Division of Liquor. This permit grants the permit holder the privilege to sell alcoholic beverages at the above listed address.

An inquiry of liquor violations revealed that the permit holder has received the following violations in **2020**:

A review of the Columbus Division of Police records revealed the Division of Police has created **(107) one hundred and seven** official police reports concerning incidents at the listed liquor establishment between **January 2019** and **November 2020**.
