This is a contract for the top-level management of the City's Wet Weather Management Plan (WWMP) program, for the period through 2012. The work in this program is a very substantial group of sewer capital improvements projects (CIPs), both collection systems and treatment works improvements, which have been agreed to by the City and Ohio EPA in order to conform to the requirements of the City's consent orders. The actual emplacement of CIPs will be by construction contract; the Professional Program Management (PPM) contract provides: program planning, scheduling, budgeting, and status reporting; construction management; design management; some design of critical projects; special services such as Value Engineering; and other services for this very large program, as directed by the City.

6. <u>An updated contract timeline to contract completion.</u>

The Contract Notice to Proceed was issued in May, 2006. The majority of the projects in this Program are required to be completed in 2010, in conformance with the WWMP. The last project will be completed in 2012.

It has been planned since the inception of this procurement that the contract will be modified, approximately annually, to provide needed monies as the program proceeds.

- A. Complete Phase 1 PMIS implementation. Continue Phase II PMIS development to cover Departments City Wide, including start-up, evaluation and implementation.
- B. Continue services of Gate Attendants and sanitary facilities for those attendants at both wastewater treatment plants until completion of most construction activities.
- C. Continue Cleaning Services for CMT trailers at both wastewater treatment plants until completion of use for construction activities.
- D. Complete close-out of construction Contracts J209, J210, J211, J212, S70, S71, S72, S73, S74, S75, and S76.
- E. Continue Instrumentation and Controls Application Programming for all PPM projects extending through the duration of the program.

- F. Continue development and implementation of Standard Operating Procedures (SOP), Commissioning Plans and Start Up plans for various equipment and systems of all Program Projects.
- G. Continue Construction Management Services for all Program projects to ensure proper close out upon completion of construction.
