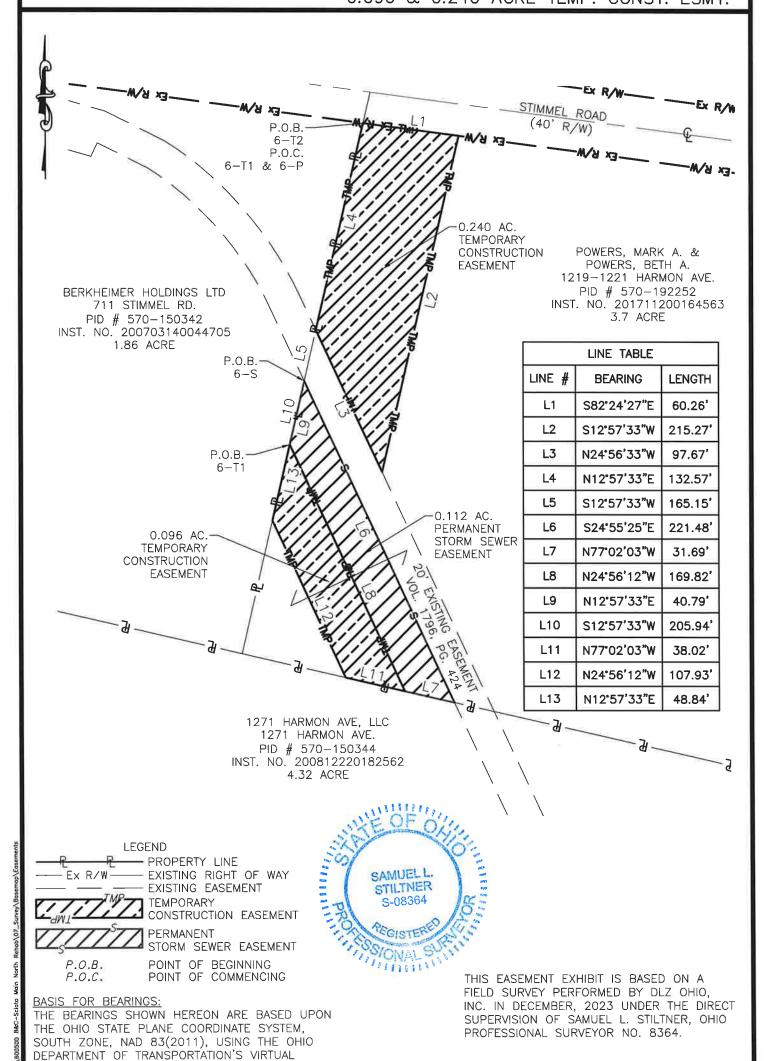

## Description of a 0.112 Acre Permanent Storm Sewer Easement Parcel 6-P

Thence South 12° 57' 33" West a distance of 165.15 feet, coincident to said 3.7 acre tract and 1.86 acre tract, to the **TRUE POINT OF BEGINNING** of the permanent storm sewer easement herein described:
