[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, Half Section 27, Township 5 North, Range 22 West, Refugee Lands, City of Columbus and being part of Block 1 of McGowans Addition to the City of Columbus, as recorded in Deed Book G, Page 70 (destroyed by fire), conveyed to Abe Bahgat by Instrument Number 200507120137264 of the Franklin County Recorder's Office and bounded and described as follows:

Being a parcel of land lying on the right side of the centerline of right of way of Livingston Avenue as shown on the centerline plat of Livingston Avenue Phase B as recorded in Plat Book 126, Page 21 of the records of Franklin County Recorder's Office and being further described as follows:

BEGINNING at the Grantor's northeast corner and the intersection of the south existing right of way of Livingston Avenue (60' right of way, as dedicated in Deed Book F, Page 332, destroyed by fire and replatted in Plat Book 3, Page 247 and also represented in Plat Book 14, Page 27, and as dedicated in Deed Book G, Page 70, destroyed by fire) and the west existing right of way of Lazelle Street (30' right of way as dedicated in Deed Book G, Page 70, destroyed by fire), 30.00 feet right of Livingston Avenue station 31+40.75 and 15.00 feet left of Lazelle Street station 9+72.46;

Thence on the west existing right of way of Lazelle Street and the Grantor's east line, **South 07 degrees 56 minutes 50 seconds East**, a distance of **15.31 feet** to a point, 15.00 feet left of Lazelle Street station 9+57.14;

Thence through the Grantor's lands, the following four (4) courses:

1. **North 86 degrees 19 minutes 15 seconds West**, a distance of **1.02 feet** to a point, 16.00 feet left of Lazelle Street station 9+57.35;
2. **North 07 degrees 56 minutes 50 seconds West**, a distance of **9.19 feet** to a point, 16.00 feet left of Lazelle Street station 9+66.54;
3. **North 86 degrees 19 minutes 15 seconds West**, a distance of **12.71 feet** to a point, 36.00 feet right of Livingston Avenue station 31+28.25;
4. **North 03 degrees 40 minutes 45 seconds East**, a distance of **6.00 feet** to the south existing right of way of Livingston Avenue and the Grantor's north line, 30.00 feet right of Livingston Avenue station 31+28.25;

Thence on the south existing right of way of Livingston Avenue and the Grantor's north line, **South 86 degrees 19 minutes 15 seconds East**, a distance of **12.50 feet** to the **Point of Beginning**, containing 0.0020 acres, of which the present road occupies 0.0000 acres, and being part of Franklin County Auditor's Parcel Number 010-036250-00.

The bearings for this description are based on the bearing between Franklin County Engineer's monuments "FRANK143" and "COC5-83" being North 77 degrees 09 minutes 24 seconds West, as resolved by GPS observations, using Grid North, of the Ohio State Plane Coordinate System, South Zone, NAD83(1986).
