Thence North 04° 50' 44" East, following the centerline of right of way of Alum Creek Drive, for a distance of 296.07 feet to the northwesterly corner of said 2.6548 acre tract and the southwesterly corner of a 3.045 acre tract as described in a deed to Shirley Adkins, or her successor, trustee of Shirley Adkins Trust, dated 11/6/96 and being on the northerly line of said Section 18;

Thence South 85° 19' 43" East, following the northerly line of said 2.6548 acre tract and the southerly line of said 3.045 acre tract, for a distance of 100.00 feet to the easterly right of way of Alum Creek Drive;

Thence South 04° 38' 43" West, passing through said 2.6548 acre tract and following the easterly right of way of Alum Creek Drive, for a distance of 20.00 feet to the **True Place of Beginning** of the parcel herein described;

Thence leaving said right of way and continuing through said 2.6548 acre tract for the following three (3) courses and distances;

- 1. South 85° 19' 43" East, for a distance of 270.58 feet to a point;
- 2. South 04° 40' 17" West, for a distance of 10.00 feet to a point;
- 3. North 85° 19' 43" West, for a distance of 305.67 feet to the easterly right of way of Alum Creek Drive;

Thence North 04° 50' 54" East, following said right of way, for a distance of 10.00 feet to a point;

Thence South 85° 19' 43" East, continuing along said right of way, for a distance of 35.06 feet to the **True Place of Beginning**, and containing 3,056 square feet or 0.070 acres of land, more or less, in Franklin County Auditor Parcel Numbers 530-162084, of which Present Road Occupied is 0.000 acres of land.
