



## ***Robert K. Smith, AIA***

Mr. Smith is a Principal and the Manager of Architecture & Interior Design. He is responsible for scheduling and overview of the Architects and Interior Design projects & personnel for Schooley Caldwell Associates. He is the primary Code Analyst and directs all projects through the code review and plan approval process.

A specialist in the planning and design of office buildings and tenant space, Mr. Smith also serves as project architect and project manager overseeing space needs analysis, construction documents, and project management and coordination for projects involving office buildings, schools and universities, as well as work for the federal government.

Mr. Smith received his Bachelor of Science degree in Architecture from The Ohio State University in 1976. He obtained his Architectural registration from the State of Ohio in 1982, holds an NCARB certificate, and is an active member of the American Institute of Architects, AIA Ohio, and the AIA Columbus. He is currently President of the Ohio Design Professionals and Code Analysts, and a professional member of the Building Officials Code Administrators.

### ***CODE ANALYST EXPERIENCE***

Mr. Smith has worked extensively with the Ohio Department of Commerce, Division of Industrial Compliance and the Board of Building Standards. He has completed projects (plan approval and certificate of occupancy) in 35% of Ohio's Counties, and has completed over 50 projects in Columbus and the Columbus suburban communities. Mr. Smith has worked successfully with building departments and government agencies to ensure that all SCA projects are designed and constructed to protect the health, safety and welfare of the occupants and that all building codes are followed.

Mr. Smith's experience includes many successful sessions before the Ohio Board of Building Appeals. The Ohio Statehouse restoration project required a coordinated effort of the Division of Factory and Building Inspection, the Division of Plumbing Inspection, and the Board of Building Appeals. Mr. Smith led this project through preliminary, plan approval, appeals, temporary occupancy, and occupancy. Mr. Smith has provided the code analysis for over thirty (30) Schools in Ohio, twenty (20) university buildings in Ohio, and thousands of residential units for the U.S. Air Force & U.S. Navy. The emphasis of this code analysis is with the restoration of public institutions' public projects that require a comprehensive knowledge of the building codes. He has the ability to mesh building code requirements into the framework of existing buildings and keep the primary features and fabric of those buildings intact. This ability comes from many years of experience in both code analysis and working to renovate significant historic structures. He has garnered support and guidance from the many Building Officials, Fire Chiefs, Board of Appeals, and the Model Code agencies. This support and guidance has been extremely helpful in the design and construction of many of Ohio's most prized possessions such as the Ohio Statehouse, Ohio Courts Building, Downtown Lazarus Redevelopment, and Franklin Park Conservatory.
