[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, City of Columbus located in Quarter Township 1, Township 1, Range 19 (USML) and being a part of a 0.330 acre tract of land conveyed to Kenny Centre Ventures, LLC by deed of record in I.N. 200309150293808 of the Recorders office, Franklin County, Ohio and being more particularly described as follows:

Beginning at a point, said point being 40.00 feet left of station 60+46.12, said point being the point of beginning;

Thence N 87°35'55" W a distance of 20.00 feet to a point, said point being 60.00 feet left of station 60+45.69;

Thence N 03°38'56" E a distance of 125.01 feet to a point, said point being 60.00 feet left of station 61+70.69;

Thence S 87°35'55" E a distance of 20.00 feet to a point, said point being 40.00 feet left of station 61+71.13;

Thence S 03°38'56" W a distance of 125.01 feet to the point of beginning.

The above described area is contained with the Franklin County Auditor's Parcel Numbers 010-009949 (0.034 acres) and 010-010816 (0.023 acres), for a total within said boundary is 0.057 acres, more or less.

The centerline described in this document refers to the centerline of construction as shown on the City of Columbus roadway plan "Kenny Road Sidewalk Improvements (3113 Dr. E)".

The basis of bearings in this description area based on the State Plane Coordinate System, Ohio South Zone, NAD83 (NSRS 2011), which were determined by GPS observations conducted by the Patrick Engineering survey staff. The Columbus, Mount Vernon and McConnelsville CORS stations were used, which establishes a bearing along the centerline of Kenny Road to be N 3°17'54"E between Henderson Road and station 86+01.50 (just south of Weybridge Road).
