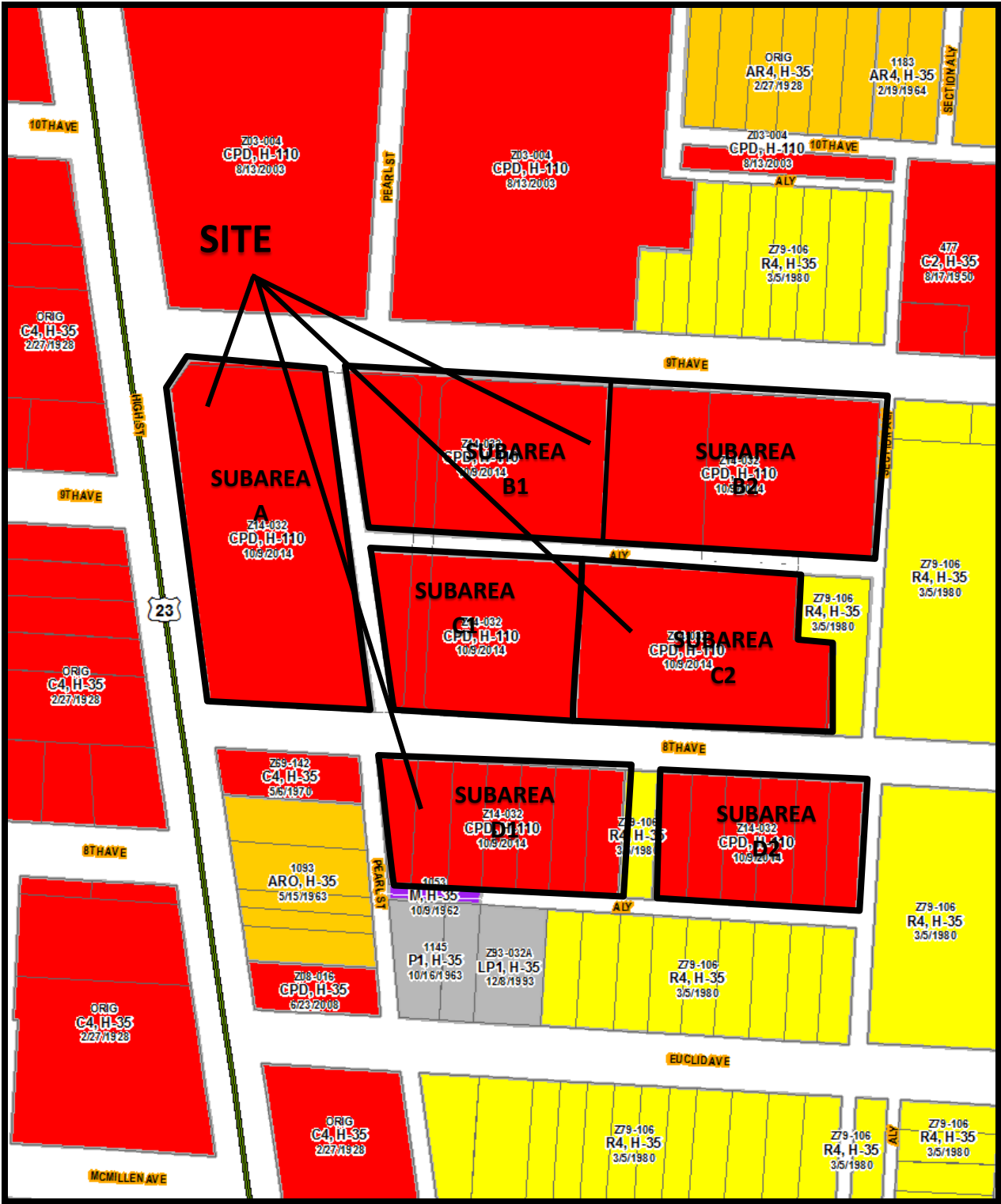

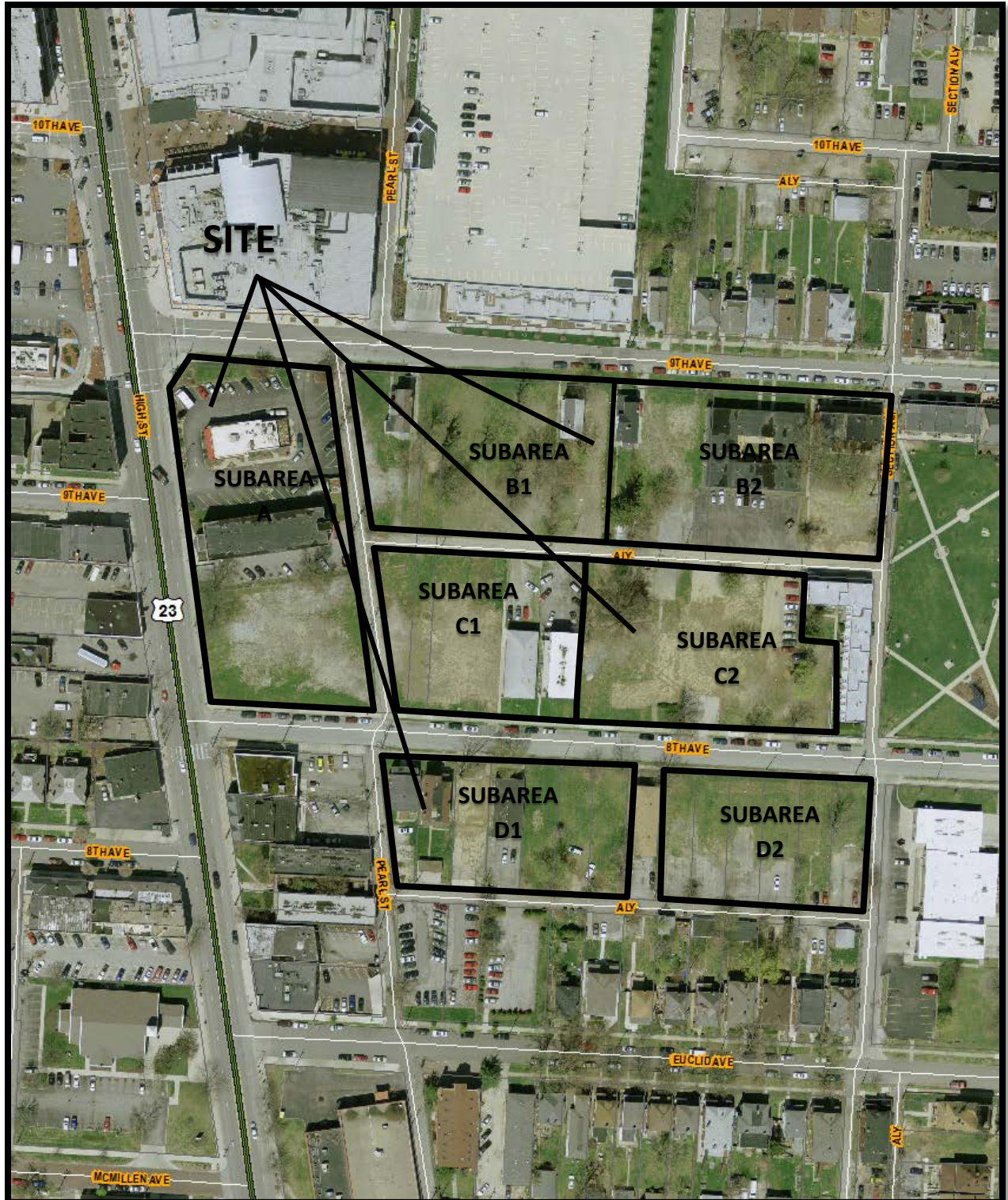

This letter is to inform you that on February 18, 2015 the UAC voted to approve revisions to the previously approved CPD text for the South Gateway development located at 1516 N. High Street.

The requested changes will permit an **8.5 ft. x 18 ft.** parking space rather than the city-wide standard parking space of 9 ft. x 18 ft.

Although the vote to approve the requested modification was unanimous, it should be noted that as there was an enormous amount of time and deliberation spent on this particular CPD rezoning, and as many community groups and neighborhood members had significant input into this process, it was strongly noted that no further requests for variance should be submitted on this project.

The vote to approve the above request was as follows: **For – 16; Against –0; Abstentions – 0.**

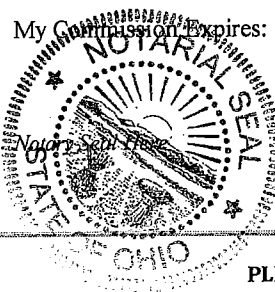
