Commencing at a monument set at the centerline intersection of Francisco Road and Kenny Road, said point being the southwest corner of the 4.413 acre tract of land conveyed to Storage Equities INC/PS, Partnership III by deed of record in OR 5939 I16, and the southeast corner of a right-of-way parcel conveyed to the City of Columbus in OR 10904 A01 (43-WD), and being at station 91+16.16;

Thence N 16°20'19" E along the centerline of right-of-way Kenny Road and said Columbus right-of-way parcel a distance of 52.23 feet to a PK nail set at grantor's southwest corner, said nail being 11.50 feet right of station 91+67.11 and being also the TRUE POINT OF **BEGINNING**;

Thence N 16°20'19" E along the grantor's west line and said former centerline of Kenny Road a distance of 100.38 feet to an iron pin set on the east right-of-way line of Kenny Road as conveyed to the City of Columbus in OR 5669 H07, said iron pin being 33.65 feet right of station 92+65.02 (projection of tangent);

Thence crossing the grantor's 2.697 acre tract S 2°46'33" W along said right-of-way line of Kenny Road a distance of 85.33 feet to an iron pin set on the east right-of-way line of Kenny Road, said iron pin being 34.89 feet right of station 91+79.70;


The above described area is contained with the Franklin County Auditor's Parcel Number 010-129791. Within said boundary is 0.027 acres, more or less, including 0.026 acres of present road occupied, for a net take of 0.001 acres.

This description and survey was prepared and reviewed on February 27, 2015, by Joseph S. Bolzenius.

All iron pins set are 5/8" rebar (30" long) with a yellow plastic cap stamped "R/W PATRICK INC" and are to be placed at the completion of construction by the City of Columbus Survey Department.

The centerline and stationing described in this document refers to the centerline of construction on file with the City of Columbus plan "Kenny Road Sidewalk Improvements (3113 Dr. E)".

The basis of bearings in this description area based on the State Plane Coordinate System, Ohio South Zone, NAD83 (NSRS 2011), which were determined by GPS observations conducted by the Patrick Engineering survey staff. The Columbus, Mount Vernon and McConnelsville CORS stations were used, which establishes a bearing along the centerline of Kenny Road to be N 3°29'58"E between Weybridge Road and Francisco Road.
