

AMENDMENT ONE TO CONTRACT FOR SERVICES

BETWEEN

SHOTSPOTTER, INC. AND THE CITY OF COLUMBUS, DEPARTMENT OF PUBLIC SAFETY

This Amendment One (this "Amendment") to the Contract for Services dated October 4, 2018, by and between ShotSpotter, Inc. ("ShotSpotter") and the City of Columbus, Department of Public Safety ("City") (the "Contract"), is effective as of the last date of signature below. Except as modified herein, all other terms and conditions of the Contract remain in full force and effect. In the event of a conflict between the terms and conditions of the Contract and this Amendment, the terms and conditions of this Amendment shall control. ShotSpotter and City may also be referred to herein individually as a "Party", or collectively as the "Parties".

WHEREAS, the Contract and its Exhibits set forth the terms and conditions under which ShotSpotter would provide its gunshot detection, location, and forensic analysis services to the City on an annual subscription basis; and

WHEREAS, due to current economic circumstances resulting from the COVID-19 pandemic, the Parties desire to modify the City's 2020 annual renewal.

NOW, THEREFORE, the Parties agree as follows:

1. City desires, and ShotSpotter agrees to modify the renewal period for the City's 2020-2021 subscription term from an annual renewal, to a six (6) month renewal period effective February 7, 2020 through August 6, 2020 as shown in Exhibit A hereto and adjusts the subscription periods for Phase IB and Phase IC to be coterminous with Phase IA.
2. The subscription fees for this six (6) month coterminous renewal period are set forth in Exhibit A.
3. Prior to August 6, 2020, the City will notify ShotSpotter whether or not the City is able to further renew its subscription services; and if so, for what timeframe.
4. Based on notification from the City regarding the City's ability to renew the ShotSpotter subscription services beyond August 6, 2020, the Parties will re-evaluate any additional amendment that may be required.


