#### Director,

Per your direction, the Division of Design and Construction has reviewed the City's engineer's estimate for the Bridge Rehabilitation - Major Bridge Rehabilitation project. They reviewed the accessibility for the contractor to work underneath the Calumet structure and the challenges they may face. Based on this degree of difficulty, they revised some of the estimates of the bid items accordingly. They made some estimate adjustments to other items, based on small quantity, limited available bid unit prices to compare, and added railroad insurance cost that was not included in GPD's estimate. The revised bid tab with engineer's estimate is attached.

This memorandum is a recommendation for construction contractor selection and processing the construction legislation for the Bridge Rehabilitation – Major Bridge Rehabilitation project contract for Calumet Street over Glen Echo Ravine bridge and Fisher Road over CSX and Norfolk Southern Railroad West/I-270 bridge.

#### Project Scope:

This project consists of the rehabilitation of the Calumet Street Bridge over the Glen Echo Ravine and the Fisher Road bridge over the CSX and Norfolk Southern Railroad west of I-270. The rehabilitation of the Calumet Street bridge includes asphalt overlay and resurfacing, patching of superstructure and substructure, fiber reinforced polymer wrapping, concrete sealing, and repair of channel protection. The rehabilitation of the Fisher Road bridge consists of minor superstructure rehabilitation of the existing bridge on Fisher Road over the CSX and Norfolk Southern Railroad, including removing and replacing the vandal protection fence, and removing and replacing the existing concrete parapets, and such other work as may be necessary to complete the contract in accordance with the plans and specifications set forth in the Bid Submittal Documents.

Fiscal Impact: Source of funds are 2010 Bonds Fund.

<u>Schedule:</u> Bids were opened November 30, 2010; estimated Council date is January 10, 2011; estimated NTP date is May 2, 2011. All work shall be completed by July 29, 2011.
