[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, City of Columbus, being located in Quarter Township 4, Township 2, Range 17 of the United States Military Lands and being 0.085 acres within a 10.705 acre parcel conveyed to CHRISTOPHER M KRISIEWICZ, SUCCESSOR TRUSTEE as described in Instrument Number 201509110128077 and being more particularly described as follows:

Being a parcel of land lying on the left side of the centerline of a survey made for project Hamilton Road, made by the Department of Transportation, and being located within the following described points in the boundary thereof:

Beginning at an iron pin set on the westerly proposed right-of-way of Hamilton Road, said point being 65.00 feet left of centerline Station 64+48.25;

Thence along the southerly property line of said 14.719 acre tract, North 86°21'06" West, a distance of 8.00 feet to a point, being 73.00 feet left of Hamilton Road centerline Station 64+48.30;

Thence across the said 14.719 acre tract, North 3°18'14" East a distance of 34.70 feet to a point being 73.00 feet left of centerline Hamilton Road Station 64+83.00;

Thence across the said 14.719 acre tract, South 86°41'46" East a distance of 3.00 feet to a point being 70.00 feet left of centerline Hamilton Road Station 64+83.00;

Thence across the said 14.719 acre tract, North 3°18'14" East a distance of 252.00 feet to a point being 70.00 feet left of centerline Hamilton Road Station 67+35.00;

Thence across the said 14.719 acre tract, North 37°36'38" West a distance of 19.85 feet to a point being 83.00 feet left of centerline Hamilton Road Station 67+50.00;

Thence across the said 14.719 acre tract, North 3°18'14" East a distance of 75.02 feet to a point being 83.00 feet left of centerline Station 68+25.02;

Thence across the said 14.719 acre tract, North 86°41'46" East a distance of 13.00 feet to a point being 70.00 feet left of centerline Station 68+25.02;

Thence across the said 14.719 acre tract, North 3°18'14" East a distance of 129.98 feet to a point being 70.00 feet left of centerline Station 69+55.00;

Thence across the said 14.719 acre tract, South 86°41'46" East a distance of 5.00 feet to a point on the proposed westerly right-of-way line of Hamilton Road, being 65.00 feet left of centerline Station 69+55.00;

Thence along the proposed westerly right-of-way line of Hamilton Road, South 3°18'14" West a distance of 506.75 feet to the point of beginning, containing 0.085 acres, more or less.

The above described area is within Auditors Permanent Parcel Number 600-254098.

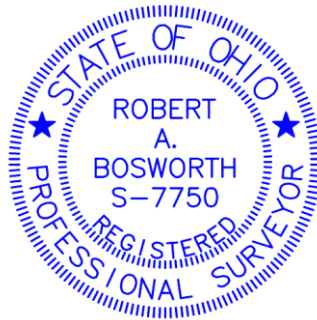
