Situated in the State of Ohio, County of Franklin, City of Columbus, Quarter Township 4, Township 1 North, Range 16 West, United States Military District, being part of a 1.840 acre tract of land in the name of EAST BROAD & NEW ALBANY RD. DUCHESS, LLC, an Ohio limited liability company as described in Instrument Number 201603040026272, all records are on file with the Franklin County Recorder's Office, and being a tract of land lying on the left side of the centerline of Right-of-Way of State Route 16 (East Broad Street) (R/W Varies) and is more particularly described as follows:

Commencing at a 1" iron pin set in a monument box assembly at the centerline of Right-of-Way intersection of said State Route 16 (East Broad Street) and Rosehill Road (R/W Varies), said intersection being centerline Station 227+31.51 of said State Route 16 (East Broad Street) and centerline Station 410+00.00 of said Rosehill Road, referenced by a 1" iron pin found in a monument box bearing South 81°51'39" West a distance of 662.31 and being 0.02 feet right of centerline Station 220+69.20 of said State Route 16 (East Broad Street);

Thence North 81°51'39" East, with the centerline of Right-of-Way of said State Route 16 (East Broad Street), a distance of 2,467.77 feet to the southeasterly corner of a certain tract of land in the name of the State of Ohio as described in Instrument Number 199802130033174, also being the southwesterly corner of said 1.840 acre tract, said corner being centerline Station 251+99.28;

Thence North 07°22'45" West, a distance of 110.01 feet to a point in the northerly Right-of-Way line of said State Route 16 (East Broad Street), being the southeasterly corner of a 1.165 acre tract of land in the name of REGENCY CENTERS, L.P., a Delaware limited partnership as described in Instrument Number 199805080112954 and 110.00 feet left of centerline Station 252+00.74, said corner referenced by a 5/8" iron pin with a identification cap stamped "BIRD&BULL" found bearing South 63°03'59" West a distance of 0.08 feet;

Thence North  $81^{\circ}51'39''$  East, with said northerly Right-of-Way line, a distance of 76.26 feet to a point being 110.00 feet left of centerline Station 253+77.00 and the **True Place of Beginning** for the tract of land herein described;

Thence through said 1.840 acre tract, the following three (3) courses:

- 1) **North  $08^{\circ}08'21''$  West**, a distance of **20.00 feet** to a point being 130.00 feet left of centerline Station 252+77.00;
- 2) **North  $81^{\circ}51'39''$  East**, a distance of **87.00 feet** to a point being 130.00 feet left of centerline Station 253+64.00;
- 3) **South  $08^{\circ}08'21''$  East**, a distance of **20.00 feet** to a point in said northerly Right-of-Way line, being 110.00 feet left of centerline Station 253+64.00;
- 4) Thence **South  $81^{\circ}51'39''$  West**, with said northerly Right-of-Way line, a distance of **87.00 feet** to the **True Place of Beginning**.

The above described area contains 0.040 acres more or less, which is part of Franklin County Auditor's Permanent Parcel Number 010-007120-00.

Bearings for this description are based on Ohio State Plane Coordinates, South Zone, NAD 83 (2007) Datum as established using a GPS survey performed in October 2020, holding North  $81^{\circ}51'39''$  East for the centerline of State Route 16 (East Broad Street).

The stations referred to herein are from the existing centerline of Right-of-Way of State Route 16, as recorded on the FRA-16-7.79 centerline plat in Plat Book 29 Page 4.
