Situated in the State of Ohio, County of Franklin, City of Columbus, being part of Virginia Military District Survey number 2668, and being part of Lot 230 of the Landscape Addition as recorded in Plat Book 5, Page 320, and part of a 0.150-acre tract conveyed to Desire Goodwin by Instrument No. 202202250031324 in the Franklin County Recorder's Office and described as follows:

**Beginning** at a point at the intersection of the northerly existing right of way line of Olive Street (50 feet wide), and the easterly existing right of way line of an alley (15 feet wide) and being the southwesterly corner of Lot 230 of the Landscape Addition as recorded in Plat Book 5, Page 320, and the southwesterly corner of said 0.150-acre tract being 25.00 feet left of Station 28+40.81 Olive Street:

Thence North 02°49'37" West, a distance of 2.90 feet along the easterly existing right of way line of said alley and the grantor's westerly line to a point being 27.90 feet left of Station 28+40.83 Olive Street;

Thence North 86°50'42" East, a distance of 36.24 feet leaving the westerly existing right of way line of said alley across the grantor's property to a point being 27.90 feet left of Station 28+77.07 Olive Street:

Thence South 03°09'18" East, a distance of 2.90 feet continuing across the grantor's property to a point on the northerly existing right of way line of Olive Street and the grantor's southerly line being 25.00 feet left of Station 28+77.07 Olive Street;

Thence South 86°50'42" West, a distance of 36.26 feet along the northerly existing right of way line of Olive Street and the grantor's southerly line to The True Point of Beginning and containing **0.002** acres, more or less, of which 0.000 acres are within the present road occupied. Subject to all legal easements, agreements and right of way of record.
