Situated in the State of Ohio, County of Franklin, City of Columbus, being part of Lot 4 of the Scioto Land Company Partition as recorded in Deed Book A, Page 194 (destroyed by fire) and re-recorded in Deed Book A, Page 21, Quarter Township 4, Township 2, Range 18, United States Military Lands, being 0.062 acres out of a 0.507 acre tract described in a deed to Stanin Capital I, LLC, an Ohio Limited Liability Company of record in Instrument Number 201304090058014 and also being part of Reserve "B" as shown and delineated upon the plat "Karl Meadows", a subdivision of record in Plat Book 33, Pages 102 & 103, and being more particularly described as follows:

Being a parcel of land lying left of the Centerline of Right of Way of FRA-161-12.04 made by IBI Group for the City of Columbus as recorded in Plat Book 130, Page 77 in the records of Franklin County, and being located within the following described boundary points in the boundary thereof:

Thence with the arc of a curve to the right having a radius of 93.00 feet, a central angle of 11°13'00", an arc length of 18.21 feet, the chord of which bears South 28°44'57" East, a chord distance of 18.18 feet crossing said 0.507 acre tract to the east line of said 0.507 acre tract, the east line of said Reserve "B", and the west right-of-way line of Karl Road to an Iron Pin Set at an offset from the existing Karl Road of 40.00 feet Left from Station 167+76.15;

Thence with the arc of a curve to the right having a radius of 660.02 feet, a central angle of 05°24'57", an arc length of 62.39 feet, the chord of which bears South 02°11'15" East, a chord distance of 62.36 feet along the east line of said 0.507 acre tract, the east line of said Reserve "B", and the west right-of-way line of Karl Road to an Iron Pin Set at an offset from the existing Karl Road of 40.00 feet Left from Station 167+10.00:

Thence South 03°29'30" West 5.11 feet crossing said 0.507 acre tract and said Reserve "B", to the **TRUE POINT OF BEGINNING**, containing 0.062 acre of land more or less out of Franklin County Auditor's parcel number 010-087367-00, 0.000 acres of which lie within the present right of way of Karl Road.

**Basis of Bearing**: Bearings are based on data acquired by GPS observations as per NAD 83 (2011) – Ohio State Plane Coordinate System – South Zone, which sets the centerline of State Route 161 as South 86°30'56" East. State Route 161 and Karl Road centerline Stationing was established from State of Ohio Department of Transportation right-of-way plan FRA-161-11.57 as established for this project.

The above description is based on and referenced to State of Ohio Department of Transportation right-of-way plan FRA-161-12.04 prepared by IBI Group attached hereto and made a part hereof. All references are to the records of the Recorder's Office, Franklin County, Ohio.
