Thence along the northerly line of Lot 81 and the southerly line of Lot 80, **South 81 degrees 02 minutes 30 seconds East, 1.75 feet** to a point 41.75 feet Right of Station 75+09.39 of the Centerline of Right-of-Way of Worthington Woods Boulevard;

Thence crossing Lot 81, along a curve to the left having a Delta Angle of 02 degrees 32 minutes 34 seconds, a Radius of 708.25 feet, an Arc Length of 31.43 feet, along a Chord Bearing **South 07 degrees 41 minutes 13 seconds West, 31.43 feet** to a point, said point being 41.75 feet Right of Station 74+76.10 of the Centerline of Right-of-Way of Worthington Woods Boulevard;

Thence crossing Lot 81, **South 06 degrees 24 minutes 56 seconds West, 51.68 feet** to the southwest corner of Lot 81, and in the easterly right-of-way line of Worthington Woods Boulevard, said point being 40.00 feet Right of Station 74+22.24 of the Centerline of Right-of-Way of Worthington Woods Boulevard;

Thence along the westerly line of Lot 81, and the easterly right-of-way line of Worthington Woods Boulevard, **North 03 degrees 21 minutes 07 seconds East, 13.76 feet** to a point, said point being 40.00 feet Right of Station 74+36.00 of the Centerline of Right-of-Way of Worthington Woods Boulevard;

Thence along the westerly line of Lot 81, and the easterly right-of-way line of Worthington Woods Boulevard, along a curve to the right having a Delta Angle of 05 degrees 36 minutes 23 seconds, a Radius of 710.00 feet, an Arc Length of 69.47 feet, along a Chord Bearing **North 06 degrees 09 minutes 19 seconds East, 69.45 feet** to the TRUE POINT OF BEGINNING, containing 0.0026 acre (114 Square Feet), more or less, all of which is contained within Franklin County Auditor's Parcel Number 610-197833-00.

Subject to all, legal, easements, rights-of-way, conditions and restrictions.

Bearings are based on the Ohio State Plane Coordinate System, South Zone, NAD83(2011). Said bearings originated from a field traverse which was referenced to said coordinate system by Static GPS observations processed through OPUS.
