BEGINNING at the southeast corner of Lot 34 as shown on the Amended Plat of James J. Beards Subdivision, P.B. 2, pg. 240, being referenced by a found 3/4" iron pipe (0.006' N, 0.44' W), and being the intersection of the north right of way line of Fulton St. (60' wide) and the west line of Glover Al. (20' wide, also see D.B. 331, pg. 75), both dedicated in said James J. Beard Subdivision;

THENCE South 88 degrees 32 minutes 15 seconds East 50.01 feet, crossing the said Glover Al., along the north right of way line of the said Fulton St. and the south line of Lot 13 of the said Clara A. Kinnear's Oakwood Ave. Addition, to a set iron pin, being the southeast corner of the said Lot 13, the intersection of the north right of way line of the said Fulton St. and the west right of way line of the said 10' wide alley, and being the True Point of Beginning;

THENCE North 03 degrees 37 minutes 21 seconds East 66.00 feet, along the east line of the said Lot 13 and the west right of way line of the said 10' wide alley, to a set iron pin;

Kinnear's Oakwood Ave. Addition, to a set iron pin, being the southwest corner of the said Lot 12, and the intersection of the north right of way line of the said Fulton St. and the east right of way line of the said 10' wide alley;
