Beginning, at a P.K. nail set at the southwesterly corner of that 0.209 acre tract of land as conveyed to Nationwide Children's Hospital of record in Instrument No. 201411210155990, said corner also being the southwesterly portion of Putnam Alley (20') declared as "excess right-of-way" by the City of Columbus in Ordinance #1588-2014, being in the easterly line of that tract of land described as Tract I as conveyed to Nationwide Children's Hospital of record in Instrument No. 202101080005181, at the northwesterly corner of said remaining Putnam Alley (20') and at a common corner of Lot 169 and 170 of said Swayne's Additions plat;

Thence S 86° 32' 04" E, with the southerly line of said 0.209 acre tract, along the southerly terminus of the vacated portion and northerly terminus of said remaining Putnam Alley (20'), 20.00 feet to a P.K. nail set at a common corner thereof, said corner also being the southwesterly corner of that tract of land described as Tract V as conveyed to Nationwide Children's Hospital of record in Instrument No. 202101080005181, the northwesterly corner of that tract of land as conveyed to Nationwide Children's Hospital of record in Instrument No. 202109300175204 and the common corner of Lot 224 and Lot 223 of said Swayne's Additions plat;

Thence S 03° 31' 48" W, with the easterly right-of-way line of said remaining Putnam Alley (20'), the westerly line of said Nationwide Children's Hospital tract (I.N. 202101080005181), the westerly line of that tract of land described as Tract IV as conveyed to Nationwide Children's Hospital of record in Instrument No. 202101080005181 and the westerly lines of Lots 223 and 222 of said plat, 90.00 feet to an iron pin set at the southwesterly corner of said Tract IV, also being the northwesterly corner of that tract of land as conveyed to Rodriguez Properties LLC of record in Instrument No. 201106090072938 and the common corner of Lot 222 and Lot 221 of said Swayne's Additions plat;

Thence N 86° 32' 04" W, across said remaining Putnam Alley (20'), 20.00 feet to a P.K. nail set in the easterly line of said Tract I, the westerly right-of-way line of said Putnam Alley (20') and being at the common corner of Lot 172 and Lot 171 of said plat;

Thence N 03° 31' 48" E, with the easterly line of said Tract I, the easterly lines of Lot 171 and Lot 170 of said plat and along said westerly right-of-way line, 90.00 feet to the True Point of Beginning, and containing 0.041 acres, more or less.

Subject, however, to all legal highways, easements, and restrictions.
