BEGINNING at the southeasterly corner of said Lot 57 and the northeasterly corner of Lot 56 of said "American Addition", being in the westerly right-of-way line of Cushing Alley (20 feet wide);

Thence North 85° 53' 11" West, with the line common to said Lots 57 and 56, a distance of 4.00 feet to a point;

Thence North 04° 06' 54" East, crossing said Lot 57, a distance of 35.00 feet to a point in the line common to said Lots 57 and 58;

Thence North 85° 53' 11" West, with said common line, a distance of 2.00 feet to a point;

Thence North 04° 06' 54'' East, crossing said Lots 58 and 59, a distance of 40.00 feet to a point;

Thence South 85° 51' 50" East, continuing across said Lot 59, a distance of 6.00 feet to a point in said westerly right-of-way line;

Thence South 04° 06′ 54″ West, with said westerly right-of-way line, a distance of 75.00 feet to the POINT OF BEGINNING, containing 0.009 acre, more or less, of which the present road occupies 0.000 acre and 0.003 acre is part of Franklin County Auditor's Parcel Number 010-126303, 0.005 acre is part of Franklin County Auditor's Parcel Number 010-126242, and 0.001 acre is part of Franklin County Auditor's Parcel Number 010-126534.
