Situated in the State of Ohio, City of Columbus, Franklin County, and being part of Lot 34 in Hazelwood Addition, as recorded in Plat Book 7, Page 228, and conveyed to Sandra K. Friend in Instrument Number 201708040108024, as recorded in the Franklin County Recorder's Office, and more particularly described as follows:

COMMENCING at the northwest corner of said Lot 34, and the east line of Lot 33 of said Hazelwood Addition and the south right of way of Springmont Avenue, said point being 25.00 feet right of centerline of existing right of way of Springmont Avenue at station 205+82.11, said pin being the **TRUE POINT OF BEGINNING** for the parcel herein described:

- 1) **Thence**, along the north line of said Lot 34, **North 76 degrees 46 minutes 51 seconds East, 25.00 feet** to a point, said point being 25.00 feet right of the centerline of existing right of way of Springmont Avenue at station 206+07.11;
- 2) **Thence**, across the grantor's tract, **South 13 degrees 13 minutes 09 seconds East, 6.00 feet** to a point, said point being 31.00 feet right of the centerline of existing right of way of Springmont Avenue at station 206+07.11;
- 3) **Thence**, across the grantor's tract, **South 76 degrees 46 minutes 51 seconds West, 25.00 feet** to a point on the west line of said Lot 34 and the east line of said Lot 33 of Hazelwood Addition, said point being 31.00 feet right of the centerline of existing right of way of Springmont Avenue at station 205+82.11;
- 4) **Thence**, along the west line of said Lot 34 and the east line of said Lot 33 of Hazelwood Addition, **North 13 degrees 13 minutes 09 seconds West, 6.00 feet**, to the **TRUE POINT OF BEGINNING**.

The parcel of land described contains, 0.003 acres, more or less, and is located in Franklin County Auditor's Parcel Number 010-067615.
